It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **KARTIK SARKAR** (Present User), S/O- Lt Gajen Sarkar, Address- Chandmuni Tea Estate for illegally reconnecting a deemed disconnected premises (Disconnection Date-11.03.2022) having an OSD of Rs. 15,482/- (LPSC-Rs. 5,102/- as on 31.05.2023)

Today i.e on 31.05.2023(14:30 hrs), I came to Chandmuni Tea Estate, Pin-734003; in my official hired vehicle for a routine inspection. I was accompanied by (i) Pranab Sikder, S.O(S&LP), Darjeeling Region, (ii) Prakash Dutta, JE (Gr-II), Pradhannagar CCC, (iii) Rabi Shankar Singh, O.E, Pradhannagar CCC & other technical staffs of Pradhannagar CCC. On inspection of the premises (after observing all formalities), I found that the meter **L1250562** (Deemed Disconnected, Date of Disconnection-11.03.2022) is running and **KARTIK SARKAR** is enjoying power through the meter.

Meter No- **L1250562** is in the name of **LAXMAN MAHATO**.

KARTIK SARKAR was drawing a power of 0.59 KVA.

I disconnected the connection of **KARTIK SARKAR** & seized the meter **L1250562**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter **L1250562** 240V, 5-30A, Make- Landys Gr (L/R-12132)

KARTIK SARKAR is the present user of the premises and received the copy of Notice, Inspection Note & Seizure list.

As such, **KARTIK SARKAR**, is enjoying power illegally in his deemed premises by reconnecting a deemed disconnected meter

KARTIK SARKAR is liable for prosecution U/S 138 1 (b) of Electricity Act 2003.
