Sir,

I Sova Tamang, wife of Sri. Uday Lama, R/o Bikash Nagar Dabgram, Salugara Bhaktinagar Jalpaiguri Pin 734008, belonging to ST Community in the state of West Bengal, would like to make a complain before you that:

1. That my husband is a senior citizen(75 years), belonging to ST community in the State of West Bengal, remain unwell most of the times with high blood pressure various old age ailments.
2. That my husband named Sri. Uday Lama is having an ancestral property situated at BSF Road, Girini Busty near Tamang Gomba, Salugara 734008, where we are staying on the ground floor and my Sister-in-law Smt.Chaya Lama is staying on the top floor.
3. That the above said Mrs. Babina Lawoti a Nepali Citizen is influential powerful and financially sound being a wife of influential politician of Nepal Mr. ~~Sujan~~ Lawoti. She also possess the dual citizenship of both India and Nepal. The said Babina Lawoti time and again trespassing my home and disturbing my 75 years old husband by threatening, assaulting, insulting, abusing, harassment, mentally torturing with malafide intention to displace us from our ancestral property.
4. That on dated 26.3.2023 Mrs. Babina Lawoti called one Tshering Yolmo Owner of Children's Montessori Casa, Salugara in order to sell my property and to surrender the, portion of my husband's house to the said Tshering Yolmo Owner of Children's Montessori Casa, Salugara. On the protest of my husband both of them hacked, abused, threatened, assaulted my husband not even respecting his age and started dismantelling, measuring the premises, throwing things out of my husband's house in presence of many people around and today on dated 28.5.2023 still they haven't stopped dismantelling and shifthing things from our ancestral property.
5. That the conduct of Mrs.Babina Lawoti, is not appropriate since long time towards my family, she sold many of our ancestral property without the consent of my husband.
6. The rightful owner of the ancestral property are my husband Sri. Uday Lama and Smt. Chaya Lama, being a legal heir. The said Mrs. Babina Lawoti everytime coming from Nepal and selling of portion of the ancestral property without the consent of my husband to invest in her political career in Nepal and everytime my husband has to suffer mental and physical agony.

That therefore in order to displace my family from our house that the said Babina Lawoti in connivance with the abovesaid Tshering Yolmo trying to displace us from our ancestral house by adopting all illegal means.

8. That in 2021 with the malafide intention to grab the property and to suppress the fact she had indulge my husband and my college going son in many false criminal cases.
9. That the said Babina Lawoti of Nepal is having no locus to disturb, interfere and to trespass our ancestral property and manhandled and displace a tribal senior citizen 75 years tribal which is unethical, cruel, torturesome.
10. That if such activities are not called off, my husband and my family will have suffer irreparable loss injury and will be deprived of right to live a peaceful life and with dignity.

That, for this aforementioned reasons I pray before you and your good office to kindly investigate the matter as early as possible and do the needful.
