I, Sri. Asit Das, son of Sri Anil Das @ Anil Baran Das, resident of 2/4 Baghajatin Colony, P.O. Pradhan Nagar, P.S. Pradhan Nagar, Dist. Darjeeling, would like to you for your kind information and necessary action.

1. That I have purchased 13 Decimal of land from Prama Paswan, Son of Brahmadeb Paswan, resident of Samar Nagar, P.O. Champasari, P.O. Pradhan Nagar, Dist. Darjeeling vide four registered deed of sale being No. I-9887 for the year 2022, I-9888 for the year 2022, I-10115 for the year 2022 and I-10116 for the year 2022 being L.R. Khatain No. 6000, in R.S. Plot No. 401, corresponding to L.R. Plot No. 666, within Mouza- Kalkut, J.L. No. 44, Touzi No.91, Paragana-Patharghata, P.S. Pradhan Nagar, Dist. Darjeeling and I have mutated my name in the record of right and separate Khatians were issued in my name. .
2. That after the purchased of the said land I have bounded the said land with boundary wall and iron gate with an intention to construct temporary structure thereon after taking proper permission from appropriate authority and for that purpose I have collected and stalked building material and iron rods for the purpose of construction and have started temporary construction thereon.
3. That on 27/05/2023 one Lalbabu Prasad and one Subash Sherpa are well known land grabbers of the locality enter into my said land and stolen my iron rods and building materials from my said land after braking the Pad lock of my iron gate amounting to Rs. 1,00,000/- approx. ( Rupees One Lac) only at night without my knowledge.
4. That on 31/05/2023 I went to look after my said land and material stalked thereon when I enter into the land I found the building material were missing on inquiry I come to know that one Lalbabu Prasad and one

Subash Sherpa has stolen the said material after braking the said pad lock of my iron gate have stolen the building material kept thereon at night on 27/05/2023 and when I tried to lock the said iron gate with another lock same unknown person of Lalbabu Prasad and Subash Sherpa came to the spot and manhandle with me and threaten me with dire consequences.

So, I kindly request you to take necessary action against the accused person namely Lalbabu Prasad and Subash Sherpa and their some unknown anti-social elements for theft, cheating, criminal assault, criminal intimidation, criminal trespass at night along with house breaking article and extortion and for this act of kindness I shall remain extremely grateful to you.
