Respected Sir,

I, Manjeet Kumar, Son of Chandra Kishore Paswan, resident of Dhaknikata, Ward No. 46 of Siliguri Municipal Corporation, Champasari, P.O. Champasari & P.S. Pradhannagar, District-Darjeeling, would like to inform you as follows –

1. That my friend Vicky Thakur, son of Ramesh Thakur, resident of Dhaknikata, Ward No. 46 of Siliguri Municipal Corporation, P.O. Champasari & P.S. Pradhannagar, District- Darjeeling approached me and as a friendly help requested me for a loan amounting Rs. 1,00,000/- (Rupees One Lakh only) and I being financially sound, on his faith and trust gave him a loan of Rs. 1,00,000/- (Rupees One Lakh only) without any interest on the condition that he shall repay the debt amount to me within one month.
2. That after lapse of one month when I approached Vicky Thakur for repayment of loan amount, he ignored me by stating that he will pay the principal loan amount very soon but thereafter despite my several repeated requests to him for repayment of the loan amount he did not pay a single heed and to my shock and surprise only a week ago when again I peacefully requested him to repay the loan he grabbed my collar and threatened me with dire consequences that if I constantly urge and pressurise him for repayment of loan he will brutally beat me and my family publicly and ruin our lives.
3. That today morning Vicky Thakur called me at his residence for repayment of the said loan amount but out of fear my wife (Bharti Devi), mother (Sita Devi) and cousin sister (Lakhe Das @ Laxmi Das) did not let me go alone to his residence due to the week ago violent behaviour of Vicky Thakur and when I along with my wife, mother and sister went to his residence Bikky Thakur by wrongfully confining us locked the main gate from inside and alongwith his wife (Simla Kujur) and his mother (Dolly Thakur) first started abusing us in most vulgar languages and suddenly Vicky Thakur ran towards me and started hitting me with fists and blows and when my cousin sister came for my rescue, he tightly got the hold of her hairs and started molesting her by scratching her breasts and thereafter when my wife intervened for the rescue Vicky Thakur with his full force squeezed her throat and when she was not able to breathe he pushed her to the ground by slapping over her face but he did not stop here and my mother was also beaten up brutally by his wife (Simla Kujur) and his mother (Dolly Thakur) and thereafter Vicky Thakur warned me and my family of dire consequences that he is an

influential man having strong connections with anti-social men and support of powerful persons and if I try to access any law enforcement agency for informing about the said incident he will not hesitate in taking our lives.

4. That somehow with the help of friends and relatives we were rescued and taken for the medical treatment and my wife has been admitted in the Siliguri Civil Hospital and my family is at extreme risk of harm to our life and liberty.

I request your esteemed office to take strong and deterrent action against the above-named persons and book them under relevant penal sections as per the law of the land.

This written complaint has been typed by me as per the instruction of Manjeet Kumar and has been duly read over and Explained to him upon its completion.
