Subject: FIR regarding the FOUR unknown thieves (as recorded in CCTV) intruding office premises and damaging office premises with an intention to undergo theft of public property and WBSEDCL material at 03:15 am today (2nd June, 2023)

Sir,

This is to inform you that at 03:15 am on 2nd June, 2023, FOUR unknown miscreants (as recorded in CCTV) enter the office premises of Milanpally CCC, WBSEDCL with an intention to undergo theft. They intruded the office premises unauthorisedly and manhandled material like GI wire, PVC Cable and ACSR wire. They lifted the materials from offices premises and then decided to leave office premises with LT AB Cable, GI wire and ACSR conductor (having material value around Rs.4000). Just at the moment, the on-duty call forwarding operator heard some noise and then the thieves decided to run away from the office premise in hurry throwing and damaging WBSEDCL materials at around 03:40 am today. The miscreants were seen roaming around kiosk installed at office premises where daily collected cash are kept in vault before banking next morning. **The whole incident has been captured at the CCTV installed at office premises.**

You are therefore requested to treat this as an FIR to safe guard the interest of public property under Section 136 of Electricity Act, 2003 as well as necessary sections may be booked as per norms of IPC.
