Sr,

In producing herewith one accused person named Sandu Purti (48), S/O- Lt. Mann Singh Purti of near Illa Pal Chowdhury School, Devi Danga, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

Total of 12 bottles of Himalayan Gold 60 UP containing 600 ml (Price tagged as 155/- and total of 7.2 liters) and One bottle of Himalayan Gold 60 UP containing 600 ml (Price tagged as 155/-) taken randomly as sample for examination.

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Sandu Purti (48), S/O- Lt. Mann Singh Purti of near Illa Pal Chowdhury School, Devi Danga, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 03.06.2023, while performing mobile van duty received a source information at around 21.15 hrs. that one person named is selling liquor in his house at Illa Pal Chowdhury School, Devi Danga, PS Pradhan Nagar, Dist. Darjeeling under Pradhan Nagar Police Station without any valid license.

Accordingly, I informed the matter to the I/C PS and as per his kind direction I along with CV/242 Rakesh Mangar, CV/992 Jagadish Biswas had been to Devi Danga area under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his house.

Subsequently, I along with my force cordoned the shop and was able to detain the above noted above person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house. Further being searched the above noted seized articles were found in the said house of Sandu Purti. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain.


Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure and arrested the above-mentioned person named Sandu Purti (48), S/O- Lt. Mann Singh Purti of near Illa Pal Chowdhury School, Devi Danga, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21.35 to 22.05 hrs at the spot and arrested him after informing the ground of arrest.


I, therefore pray before your good self that a specific case may kindly be initiated against Sandu Purti (48), S/O- Lt. Mann Singh Purti of near Illa Pal Chowdhury School, Devi Danga, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
