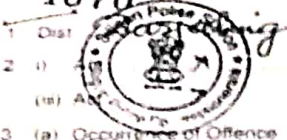

Subject: Written Complaint

Respected Sir,

I SRI VISHNU KUMAR THAKUR, S/o Late Vedanand Thakur, resident of Vill.+P.O.-Kahara, P.S.+Dist.-Saharsa, Bihar-852201, would like to bring to your kind notice the following facts:

1. That on 27.05.2023 i.e. Friday at around 11 PM I along with my 2(Two) friends namely Sri Mithilesh Kumar Mishra, S/o Late Hem Chand Mishra and Advocate Sri Lalit Kumar Agarwal, S/o Late Dhanraj Agarwal both are residents of Siliguri were returning from our work at 2nd Mile, Sevoke Road, Siliguri and on our way we stopped at a Pan Shop situated beside City Mall, situated at Sevoke Road, Siliguri, Opp. Roop Dhaba to have some water as I had consumed a very small quantity of alcohol in the evening.
2. That while we were having water standing just in front of the said shop a group of some persons who were in an intoxicated state was also there standing just beside us.
3. That suddenly one of the them who is unknown to me pushed me and in response to that I asked him that as to why you pushed me and soon after I replied him he started abusing me with slang languages continued to push me until I fell down.
4. That thereafter 6-7 persons who were the friends of that said unknown person who pushed me came forward and all of them started hitting me with fists and blows and also started kicking me on my stomach while I remain on the ground. It is also very important to mention that thereafter somehow I managed myself to stand on my feet when suddenly 2(Two) persons namely 1) Ajay Das, s/o not known, r/o not known and 2) Krishna, s/o not known, having a grill factory at Sevoke Road started hitting me with iron rod on my chest, left leg and on my stomach followed by punches on my back side of the head.
5. That seeing such tussle between me and those said 1) Ajay Das, s/o not known, r/o not known and 2) Krishna, s/o not known along with the unknown persons my

above named friends came to my rescue and the aforesaid miscreants also started hitting and abusing my friends.

6. That it is also important to mention one of my friend Sri Lalit Kumar Agarwal, S/o Late Dhanraj Agarwal who came forward to save me was having a gold chain along with 3(Three) nos. of lockets on it (Hanumanji Locket, Rudraksh and Kali Tabiz) which was also snatched by Krishna, s/o not known and my other friend Sri Mithilesh Kumar Mishra, S/o Late Hem Chand Mishra was also very badly beaten up by the aforesaid miscreants in his head and chest while he was trying to save me.
7. That it is very much important to mention that as a result of the tussle that took place between me and the aforesaid persons I have suffered a Right Rib fracture, Back Head Injury and Cramps on my left leg for which I am still receiving treatment.
8. That somehow all of us managed to escape from the spot and we went straight away to receive medical treatment at Siliguri District Hospital which was urgently required and thereafter me and my friend Sri Mithilesh Kumar Mishra, S/o Late Hem Chand Mishra went to Arogya Niketan for receiving further treatment where we were advised to take complete bed rest by the doctors.
9. That as I was arranging for my medical treatments and I was under complete bed rest so I could lodge this written complaint in the last few days.

So, I therefore humbly request you kindly take necessary legal steps against the said 1) Ajay Das, s/o not known, r/o not known and 2) Krishna, s/o not known along with the 6-7 unknown persons who were accompanying them and oblige.

This is for your information and necessary action.
