I am a legally married wife of PALLASH ROY, son of Sri.  
Hari Roy, resident of V.U. Neemtala, Kawakhali, P.O. Sush-  
rutnagar, P.S. Matigara, Dist. Darjeeling. That a Hindu  
marriage was solemnized between me and my husband  
on 16.07.2022 by performing all the rituals and ceremonies  
at my paternal house. After my marriage I started to  
live at my above mentioned residence. Since my marriage  
I have been subjected to constant physical and mental  
torment everyday. I came to know that my husband is  
a drunkard and a gambler too. After two months of  
our marriage my husband started to demand Rs.  
1,50,000 from me and my parents. He habitually uses  
vile and filthy statements related to me and my mother  
and accuses me that I and my mother are a loose  
women. When I use to oppose his illegal demands and  
accusations, he become furious and starts to assault  
me on my persons with fist, kicks, blows and with  
anything in his hands. I tolerated with a hope that he  
would change himself one by having mercy upon me  
but in vain. I informed his father who happens to stay  
at V.U. Borofapri, P.S. Bhaktinagar, Dist. Jalpaiguri, about  
his criminal activities but no fruitful result. Today  
i.e. 04.06.2023 at about 6:30 p.m. when he arrived at  
house from work he suddenly started to say to me that  
after he wins Rs. 1,00,000 in lottery he will marry  
another woman and before leaving this house he will  
kill me and feed my body to stray dogs. When I verbally  
confronted him he became furious and started to  
viciously assaulted me with fists and blows and battered me  
with wooden stick (lathi) on my persons. When I cried  
loud my neighbours rescued me from his hands.
