Respected Sir,
Please take legal steps for recovering the loan amount.

I, Ashok Chakraborty, S/o Late Palik Chak-
raborty, inhabitant of Damkim Sarani, Deshbandhupara, Ward
No-33, under N.J.P. Police Station, would like to inform you
that Mr. Ratan Sarker, S/o. Late Binoy Sarker, inhabitant
of "Aashka Apartment, Nabagram, Ward No-33, under N.J.P.
Police Station, came to me and requested me earnestly to
help him by paying a financial loan of Rs. 19, 87,000/- (Nine-
teen Lakhs and Eighty Seven Thousand) only for solving his
financial crisis. When he requested me again and again to
help him, I gave him a financial assistance cum loan of
Rs. 19, 87,000/- (Nineteen Lakhs and Eighty Seven Thousand) only
in cash before dated-25th October, 2019 before the nominee
cum guarantor Mrs. Manju Sarker, w/o. Ratan Sarker for the
period of one year (12 months) and he promised me to repay the
full amount of loan within 12 months (i.e. 26th Oct, 2019 - 25th Oct,
2020). After that when I went to him and requested him to
repay the loan amount dated 27th Oct, 2022 after expiry
of the time limit, he requested me to give him two months
extra time for repaying the amount of loan. But unfor-
tunately he did not pay the loan amount. Now whenever
I ask him to repay the amount of loan, he misguides me
and also he can not pay a single rupee to me till now.

In view of the above facts, and situation, I am request-
ing the higher authority to kindly look into my matter
and take some legal steps against him for recovering
my money and also solving my problem as soon as
possible.

If you will give your kind attention on my matter, I
shall be very benefited.
