Sub :- Prayer for lodging FIR against arrested accused person namely Chayan Roy @ Kanai Roy (19 yrs) S/O Lt. Hemanta Roy of Khoksabari, PO - Khoksabari, PS - Nilphamari, Dist - Nilphamari, Bangladesh under proper section of law.

Sir,

I, SI - Suraj Kumar Chhetri of New Jalpaiguri Police Station under Siliguri Police Commissionerate is producing herewith one arrested accused person namely Chayan Roy @ Kanai Roy (19 yrs) S/O Lt. Hemanta Roy of Khoksabari, PO - Khoksabari, PS - Nilphamari, Dist - Nilphamari, Bangladesh and do here by lodge a suomoto complaint against accused Chayan Roy @ Kanai Roy (19 yrs) S/O Lt. Hemanta Roy of Khoksabari, PO - Khoksabari, PS - Nilphamari, Dist - Nilphamari, Bangladesh to the effect that today on 02/06/2023 at about 22:15 hrs while I alongwith accompanying force C/1018 - Santosh Biswakarma, C/988 - Bhakta Biswas all are of New Jalpaiguri PS/SPC performing special van night mobile duty at PS area vide NJP PS - GDE No - 105/23 dated - 02/06/2023 received a secret source information that one person of Bangladeshi Citizen without any valid document is roaming at Gatebazar area. I informed O/C of NJP PS regarding this fact and as per his order left for Gatebazar area to verify the veracity of source information received which is noted above. I alongwith force reached Gatebazar at 22:35 hours. As shown and identified by the source, I apprehended...one person namely Chayan Roy @ Kanai Roy (19 yrs) S/O Lt. Hemanta Roy of Khoksabari, PO - Khoksabari, PS - Nilphamari, Dist - Nilphamari, Bangladesh. On being interrogated, he disclosed his name and address as noted above and also confessed that he is a Bangladeshi citizen and he has entered in India illegally as he was being tortured in Bangladesh. On demanding, he failed to produce any visa, passport or any valid documents in support of his entering and remaining present in the territory of India. It is found that above noted accused person has entered the territory of India without any visa, passport or any valid documents. So, I arrested him U/S 41A CrPC issuing memo of arrest and completing other formalities of arrest for violating the provision of Indian Foreigners Act. Ground of arrest duly communicated to him.

I, therefore, pray before your honour that a specific case under proper section of law may kindly be registered against arrested accused person namely Chayan Roy @ Kanai Roy (19 yrs) S/O Lt. Hemanta Roy of Khoksabari, PO - Khoksabari, PS - Nilphamari, Dist - Nilphamari, Bangladesh and arrange for its investigation.


