Sub: F.I.R. against my husband Sri Saumya Sarkar, my Mother-In-Law Smt. Lily Sarkar, my Sister-In-Law Smt. Soumyashree Sarkar and Smt. Rupashree Sarkar for committing Mental & Physical Torture upon me and also Attempting to Murder me on Demand of Dowry.

Respected Madam,

With due regards, I, **SMT. MOUSUMI SARKAR (BANIK)**, Wife of Sri Saumya Sarkar, Daughter of Sri Sukumar Banik, Presently residing at Jagat Bandhu Ashram Road, Netaji Colony, Ward No. 37 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint to the effect that my marriage was solemnized on 14.07.2009 with **SRI SAUMYA SARKAR**, Son of Late Sadhan Sarkar, Resident of Gokhel Road, 1 No. Dabgram, Ward No. 22 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006, according to Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house and subsequently, our said marriage was registered on 12.10.2009 as per the provision of Hindu Marriage Act, 1955, before the A.D.S.R. & Ex-Officio at Siliguri, Dist. Darjeeling. It is to be mentioned here that though our marriage was the outcome of our previous love and affairs but prior solemnization of our marriage, our family members have negotiated our marriage and at the time of negotiation, they have placed some demands before my parents and considering my future conjugal life, my parents have given so many valuable articles as Stridhan Properties like golden ornaments, furniture & fixtures, utensils and other household articles which are required to start a conjugal life happily, to my husband and his family members, as per their demand.

After our marriage, my husband brought me at my matrimonial house as mentioned above, where we started to live and cohabited together as husband and wife and out of our lawful wedlock, one female child was born on 03.10.2012, whose name is Miss Ariya Sarkar. It is to be mentioned here that in my matrimonial house, besides myself and my husband, my Father-In-Law (Since Deceased) and Mother-In-Law and my Sister-In-Laws were resided there but after the marriage of my Sister-In-Laws, they have started to reside at their respective matrimonial house.

After our marriage, we have passed our marital life happily for a period of few months. Immediately after elapse of few months, my husband in conspiracy with his parents have started to misbehave with me on different petty issues. They have always showed their dissatisfaction towards me as well the articles which were given by my parents at the time of marriage and taunting me in presence of their friends and relatives. My husband initially used to work in a private sector and earns a handsome amount but he did not spent any amount towards family expenditure and maintenance and on contrary, he in conspiracy with his family members, have started to create pressure upon me to bring money from my parental house for the purpose of maintaining my matrimonial house though, it is very much within their knowledge that my

father is a patient of cancer and for the purpose of his treatment, he has been incurring huge amount of money single handedly but considering my future conjugal life, my father and my other family members have paid amount to my husband as per their demand.

My husband is a person of bad character and he has been maintaining several adulterous and extra marital relation with so many ill reputed women and also engaging himself in different type of anti-social activities and in spite of knowing the aforesaid facts, his family members never make any protest against him and on contrary, they encouraged my husband to continue such illegal acts. My Mother-in-Law namely Smt. Lily Sarkar always provoked and encouraged my husband to commit torture both physically and mentally upon me with an intention to oust me from my matrimonial house forcefully and only after few months of our marriage, myself and my husband have started to reside in a rented house at Aurobinda Pally, Siliguri and in continuation of our marital life, one female child was born at Prayas Nursing Home, Siliguri and my father and other family members have bear all the expenditures towards the delivery of the said child as my husband flatly refused to incur any expenses towards the delivery the said child.

Madam, after the birth of the said child, my husband in connivance with his entire family members have started to increase the parameter of torture upon me both physically and mentally as they were not at all happy with the said child and my husband being the biological father of the said child, has flatly refused to take any responsibilities towards the said child and finally, during the period of pandemic, my husband in conspiracy with his family members, have intentionally left me and my minor daughter in the said rented house without any just cause and reason and started to reside at his parental house and passed his life lavishly with so many women. Even he did not bother to brought the outsider women in his parental house for his ill desire and used to pass life as husband and wife with the said women and his mother, even after knowing the said fact, always induced my husband to leave me permanently.

Madam, after leaving ourselves in the rented premises by my husband, I along with my minor daughter have went to my matrimonial house with an intention to lead further conjugal life with him but every time, they ousted us from their house and also threatened me not to enter into their house and finding no other alternative, I have compelled to take shelter at my parental house and since then, I along with my daughter have been residing at my parental house.

In the mean time, my Father-in-Law expired in the year of 2021 and after the demise of my Father-in-Law, I being the daughter-in-law, have visited my matrimonial house to pay my homage and respect and at that time, my Mother-in-Law and my Sister-in-Laws have induced me either to bring or arrange a sum of Rs. 1,00,000/- only for the purpose of funeral ceremony and rituals and they assured me that within a very months, they will return back the said amount to me and considering their said assurance, I have collected a sum of Rs. 1,00,000/- only from my father and handed over the same to my Mother-in-Law in presence of my husband.

Recently, my husband engaged himself in the land brokery business and its other allied businesses and he earns a very good amount from his said business and inspite of earning a very good amount, neither he nor

his mother return the said amount of my father knowing the fact that my father is a chronic patient of cancer and huge amount is required for the purpose of his treatment. As and when, I have requested my husband and my Mother-In-Law to return back the amount, they started to threaten me with dire consequences. It is to be mentioned here that my Mother-In-Law Smt. Lily Sarkar have received and collected huge amount of money illegally in the name of several illiterate women by using their signature from the Bandhan Bank and she has misappropriated huge amount of money from different illiterate women of the society.

Today i.e. on 04.06.2023 at about 09.30 A.M., I have visited my matrimonial house in order to return back the said amount of Rs. 1,00,000/- only which I have entrusted to them after the demise of my Father-In-Law and immediately after entering into my matrimonial house, when I asked and requested them to return back at least some amount out of the said money as my father is seriously ill and for the purpose of his treatment, some amount is required immediately and hearing the same, my Mother-In-Law and my husband in conspiracy with each other have started to attack upon me with an intention to kill me by pressing my throat forcefully but somehow, I rescued myself from their hands and left the place and due to their sudden attack, I have received some injury in my person and suffering with inner pain and thereafter, I went to Siliguri District Hospital, where the attending Doctor treated me.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against my husband and in laws members as per the provision of law and obliged thereby.
