Sir,

I SI Pintu Kr. Mondal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 05.06.23 around 17.15 hrs, while on duty at Venus More area found one TOTO without any registration number stationed near Venus More, in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.


