Sir,
In producing herewith one arrested accused person namely 1.Manik Sarkar (40yrs) S/O- Santosh Sarkar of Upper Bhanu Nagar, near Army Camp, W.No-43, P.S-Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1] 16 (Sixteen) bottles of OYE OYE 70 Up Country Spirit (each bottle containing 300 ml)
- 2] 04 (Four) bottles of Kachi 70 Up Country Spirit (each bottle containing 300 ml)

I, SI Rantu Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1.Manik Sarkar (40yrs) S/O- Santosh Sarkar of Upper Bhanu Nagar, near Army Camp, W.No-43, P.S-Bhaktinagar, Dist- Jalpaiguri to the effect that today on 03.06.2023 at 17.45 hrs while performing evening patrolling duty, received a source information that one person namely Manik Sarkar (40yrs) is selling liquor in his Street Shop at Upper Bhanu Nagar, under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C Bhakti Nagar PS PS and as per his kind direction myself along with force- C/374 Debraj Biswas, CV/619 Dharmendra Roy had been to Upper Bhanu Nagar, under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the area and able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the Street Hotel. Further being searched the above noted seized articles were found in the said Street Hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named 1.Manik Sarkar (40yrs) S/O- Santosh Sarkar of Upper Bhanu Nagar, near Army Camp, W.No-43, P.S-Bhaktinagar, Dist- Jalpaiguri U/S 41 Cr. P.C.after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 18:45 hrs to 19.15 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against 1.Manik Sarkar (40yrs) S/O- Santosh Sarkar of Upper Bhanu Nagar, near Army Camp, W.No-43, P.S-Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
