Respected Sir,

with due respect and humble submission, I  
[Sahil Pradhan] visited the phapdi mela <sup>P.S. Bhakti</sup> on Nagar  
at 10.00pm at night.  
3rd June, 2023. with my sister [Smriti Pradhan]  
and my friends [Tanu Roy] etc.

When we were leaving the mela premises.  
Some of the volunteers namely [Subal Ballav] and  
[Bishnu Roy], started harassing us and pushing  
my friend [Tanu Roy] scooter. When trying to leave  
the area he trapped us and started hitting us  
with slippers and slapping us just because we  
were parked on the sidelines of the road.

After which he [Subal Ballav] pushed me away  
and started hitting me with the other volunteers.  
When I tried to save myself as a self defence,  
and started pushing him then [Subal Ballav]  
attacked me with an object on the back of  
the head. Due to which my head started  
bleeding profusely.



When my sister (Smriti Pradhan) came to save me the hoodigans started pulling her hair touching her body and pushing her away. She was hurt and due to the continuous hassle her phone fell and a girl (Tanu Roy) was beaten her ear was pulled and she was hurt. They also beat us with canes and sticks.

Yesterday we had already submitted the complaint but writing it again.

Therefore, I request you to take into custody the accused people as soon as possible and get ~~the~~ justice that we deserve under the Indian constitution.

Your swift action is highly appreciated.
