

Meera Debi Prasad, Residence of Shastri Nagar, Near- Bai Grace school, ward no-41 Siliguri, do here by inform you that my father died on 9th Feb 2021 and my mother was also passed away on 30th Jan 2022. When my mother was alive I had taken full responsibility about her health as she was not well, all by my self without my siblings help. After my parents demise I became alone and I am unmarried also. Because of which my siblings are torturing and trying to kill me. For which I have lodged FIR against them (Smt. Anita Prasad Ram) on 8/8/2022 then again on 26th/09/22 regarding her criminal behaviour. Physical and mental toucher against me again on 26th. 11-2022 I complaint to welfare society (Maita Samity) because she threw me out of my house and locked the house. recent incident on dated 3/06/2023 around 1.40 pm, I was cooking food Anita Prasad Ram entered the house

created a scene along with her daughter Hridaya Prasad Ram started arguing without reason with sharp iron knife tried to attack me and tried to strangle my neck with rope. Some how I managed to escape and went to police station to do FIR against mother and daughter which was around 2 pm. After doing FIR nothing has been done against her.

In such a condition I am feeling unsafe to stay at my house. as she is trying to damage my parents properties and also my peaceful possession my house. Therefore I urgently request you to take ^{action} against her and direct her not to disturb me and interfere in my house.
