It also hold my SIM card with the mobile no. - 9641215586. I was forced to give up as he showed some sharp weapons. I could not resist him. Everyone was on the street but did not help me. Some days ago, my old phone was also stolen.

I am earnestly requesting you to look into this matter and take initiatives as soon as possible. It has been a matter of girls safety in a city like Siliguri will be waiting for your positive approach.
