I, MD Azharuddin, Son of S K Rajab Ali, Station Manager, Power House CCC, do here by lodge this complaint against SRI BHABENDRA BURMAN, S/O BAURA NATH, DABGRAM-I BHAKTINAGAR, BIKASH NAGAR, OPP. RADHA KRISHNA MANDIR, P.S. BHAKTINAGAR, JALPAIGURI (Mob: 9749769944). While on a routine inspection of the site /O BAURA NATH, DABGRAM-I BHAKTINAGAR, BIKASH NAGAR, OPP. RADHA KRISHNA MANDIR, P.S. BHAKTINAGAR, JALPAIGURI at around 02.41 pm on 05.06.2023, I, MD Azharuddin, Station Manager, Power House CCC along with other technical staffs observed that the house of SRI BHABENDRA BURMAN has been extended in an unauthorized manner hampering the safety clearance of the electrical installations of WBSEDCL. As per Indian Electricity Rules 1956, 80 (1) (a) a minimum vertical clearance of 3.7 meters & under 80 (2)(a) a minimum horizontal clearance of 1.2 meter was to be maintained between any part of the building and the Low And Medium Voltage Lines and networks of WBSEDCL. But the unauthorized encroachment of the LT Naked Wires has resulted in violation of the standards as per Indian Electricity Rules 1956, 80 (1) (a) & (2)(a). This violation may cause terrible outcomes in respect to safety hazards that will result in accidents, which might be fatal in nature.


Thus you are requested to kindly initiate an investigation against SRI BHABENDRA BURMAN, by treating this as F.I.R. This is for your information and necessary action please.
