Sub- Written Complaint.

Dear Sir,

With due respect, I Smt. Sumita Biswas, D/o Ranjit Biswas, resident of Ashighar Colony, Near Pragati Sangha Club, P.O. Ghogomali, P.S. Bhaktinagar, Dist.- Jalpaiguri, would like to inform you that there is one boy namely, Sri Habol Saha @ Sanjay Saha, son of Sri Chetan Saha, resident of Ashighar Colony, Near Pragati Sangha Club, P.O. Ghogomali, P.S. - Bhaktinagar, Dist Jalpaiguri, who used to eve tease my sister namely Miss NABANITA BISWAS, D/o Ranjit Biswas since she was at class - X, he used to chase my sister too while returning from her school and private tuition centers and also used to taunt and give indecent proposals, many complaints were made to his parents but instead of restraining him from doing such thing, his Father used to encourage him and threat our family, ultimately in the month of November 2013 while my sister was coming back from her private tuition at around 7:30 P.M., this boy came out from behind and hit her just above the neck, behind the right ear with a long dagger, for such assault my sister suffered a long deep cut injury on the hit her portion of the neck behind the ear, the injury was of such a nature that four stitches were required and for such incident Bhaktinagar, P.S. case No. 1910 of 2013, u/s 324, 307, 354A, 109, 34 of I.P.C., started and he was in judicial custody for near about three months, but once he got released on bail he again started such activities after elapse of few years in the recent past.

Today at around 2:30 P.M., while she was returning back from Siliguri Court after completing her daily conducting cases being an Advocate herself by a toto, the said Sri Habol Saha@Sanjay Saha chased her and when the Toto stopped on the traffic signal at the Ashighar More he jumped into the Toto and without wasting a single moment he assaulted her on her face repeatedly and she was shouting for help and was bleeding heavily, ultimately he took out a knife from his pocket saying "I will destroy your face so that you cannot show your face to anybody". He stabbed on her face but somehow she managed to escape from the blade of the knife but the

handle alongwith his grip fallen just below her right eye and she suffered a deep cut injury under her right eye, during this time some bystanders came and rescued her, they also caught him and took him to the Ashighar out post some body dropped her home, thereafter , I along with my Aunt, Smt. Soma Biswas brought her to Siliguri District Hospital at present she is in admitted condition at Siliguri District Hospital having a grievous injury.

This is pertinent to mention here that our entire family, alongwith my sister are facing tremendous insecurity regarding life and property.

In view of the above facts you are hereby humbly requested to investigate into the matter and take necessary legal action to do the needful.
