In producing herewith one arrested accused person namely Durgeshwar Roy (50yrs) S/o. Lt. Kalachand Roy of Birban, PO-Balaram, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- 1. 10(Ten) sealed Bottles of Himalayan Gold 60 UP Country Sprit containing 600 ML each.
- 2. 05(five) sealed bottles of "Royal Challenge" Beer containing 330 ML each.

I, ASI. SK. Tinku of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 05.06.2023 at 17:45hrs received a source information from Birban, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at his local shop for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE No. 182 dated 05.06.23. I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) C/625 Bhabendra Das and (2) C/1180 Susen Roy and (3) L/C-741 Mallika Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Birban under Ambari-Falakata OP to work out the information. At 18:05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the shop of the above noted person, situated at Birban and recovered the above noted articles from the possession of accused person namely Durgeshwar Roy (50yrs) S/o. Lt. Kalachand Roy of Birban, PO-Balaram, PS-NJP, Dist-Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses namely (1) Abhijit Majumder S/o. Lt. Ashim Majumder of Mahamaya Colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri and (2) Const. 625 Bhabendra Das of Ambari-Falakata OP, under NJP PS,SPC. The seizure was made between 18:25 hrs to 18:35 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Durgeshwar Roy (50yrs) S/o. Lt. Kalachand Roy of Birban, PO-Balaram, PS-NJP, Dist-Jalpaiguri under proper section of law.
