Sir,

With due respect I Mahesh Kalyani S/o Sri Khem Chand Kalyani resident of Ganga Sadan. Upper Gurung Busty. Siliguri. P.O & P.S Pradhan Nagar, District -Darjeeling would like to state that today i.e. 6-6-2023 the repairing work of the structure of my factory situated at Middle Palas, Debidanga, P.O-Champasari, District -Darjeeling was going and the engaged contractor cum masson namely Ram Paswan resident of Middle Palas. Birsa Munda More. Siliguri along with his labours were caring on their work of repairing of the factory structure. At about 11 am all of a sudden a Ashok Leyland goods carrier having registration No -A/F came from Middle Palas to Sishabari school ground in a very high speed and in a very rash and negligent manner has hit the bamboo structure which was supposed to be used for the repairing of factory building and after dashing the said bamboo bhara has dashed the said contractor cum masson namely Ram Paswan and one of the labour and fled away towards Sishabari School Ground resulting which both the labour and masson have sustained serious injuries on their part. The said labour and masson were immediately sent to Pulse Hospital, beside Circuit House, Champasari hospital for treatment but after seeing the condition of the Ram Paswan, the Doctors have referred him to shift at North Bengal Medical College and Hospital where the said Contactor cum masson namely Ram Paswan was declared dead and the labour is still fighting for his life and death at Pulse Hospital.

The said accident was caused due to rash and negligent driving of the said vehicle.

So requesting you to investigate the matter and take necessary legal actions said vehicle, driver and owner of the said vehicle for the interest of justice.
