With due respect I, SI Bandhan Roy of Pradhan Nagar Ps do hereby lodge this written complaint against 100-150 persons all of Debidanga side Ps. Pradhan nagar Dist. Darjeeling that on 05/06.06.23 while I am performing K-31 night mobile Van duty, received one telephonic information from the on-duty officer SI Rabindranath Sarkar, that about 60/70 persons have gathered in front of the house of Ajit Barman of Devi Danga Bazaar, near Amiyo Pal Chowdhury school and used filthy languages and threatened the family members with dire consequences and he also informed that near about 100 persons have gathered in the compound near Amiyo Pal Chowdhury school and over the issue of murder of Amrita Gosai last night. Informant Ajit Barman suspected that people may attack his house and life of the family members is at stake.

The duty officer also stated that Police interference is urgently needed. Subsequently I left to the spot near Amiyo Pal Chowdhury school, Devi Danga under Pradhan Nagar PS to look into the matter and after arriving at near Amiyo Pal Chowdhury School, Devi Danga at around 04.55 hrs on 06.06.23, found that local people of that area were creating hue and cry and was pelting stones at the house of Ajit Barman.

Seeing us some people namely Kundan Gosai, Sanjay Ghosh and others became furious and restrained us from our lawful duty. I therefore requested to the assembled mob several times loud and clearly to disperse but they did not pay any heed to it. The violent mob started using slang language to the police party and pelting of bricks and stones on us. Fortunately no one was injured. I saw that some of them were brandishing sharp cutting weapons and challenging the police team. Accordingly, I inform the duty officer for the re enforcement in the mean time while I along with associate officer and force trying to resort the violent mob for attacking Ajit Barman or his family members. Some of them took the opportunity and set fire on the house of Bikash Lohar and his brothers by putting petrol & kerosene which they brought with them in the plastics bottles and jars.

I informed the fire brigade of Matigara about the fire incident. After some time more force from the PS and Police line arrived at Quarter Line, Devidanga. On seeing the police team the agitated mob flew away from that place. I would also like to inform you that if I applied force on them there were possibilities of loss of life innocent people including women and children and also damaged private properties as the Quarter line area densely populated.

After some time fire tanker arrived and dross the fire of the house of Bikash Lohar and his brothers but the household articles were found completely damaged due to fire.

Hence, I would like to request, that specific case under proper section of law may kindly initiated against Kundan Gosai, Sanjay Ghosh and others 100 to 150 unknown persons and be arranged it investigation.
