COMPLAINT AGAINST UNKNOWN PERSONS FOR ATTEMPT TO KILL

Sir,

Most respectfully showeth, I Mrs Sanjana Sarkar W/O-Mr Samit Sarkar currently residing at Barsana Enclave, Matigara Khaprail Road, PO&PS-Matigara, District-Darjeeling, West Bengal 734010.

That, on 06<sup>th</sup> June 2023 at about 2255 hrs when I was driving back to my residence at Barsana Apartments with my disabled daughter Ms Nayantara, aged about 25 Yrs from HIG COMPLEX of Uttorayan Township after having dinner with one of our family friend Mr Harsh Kumar at his residence in TOWER 07/1001 of HIG COMPLEX via Lexican More Pocket lane to avoid the usual traffic of trucks. After crossed the multi storied Building at my left, I slowed down my car WB 74 AL 0567, HYUNDAI ASSCENT to cross the speed breaker on the road and I noticed one black motorcycle suddenly came at my front and blocked the road. The rider was wearing black Tees and the pillion rider was in a yellow striped may be Tee Shirt having brown hair and which I could notice due to the flash of my car's headlight. Though my speed was very slow, still I applied sudden brake to avoid the collision. Before I could react anything, the pillion rider got down and rushed towards me. The pillion rider assaulted me with some object and tried to give blow at my right neck area through the open window and when I bowed down to save myself, I received bleeding injury at the back side of my neck. I caught hold the object with my right hand when the pillion rider again assaulted me and I received bleeding injury on my right palm due to the sharpness of the object, which could be a knife. In the mean time I heard the bike rider saying in bengali that "Video kare upload karechhis" and "Gelo, gelo, chalchal". Due to this brutal assault I was literally fainted and when I regained my consciousness, I couldn't trace the miscreants at the incident place. Somehow I drove towards the Matigara Khaprail main road and noticed some police personnel. By taking help from the police, my family friend Mr Harsh Kumar was informed and he immediately reached the place and police personnel along with Mr Harsh Kumar evacuated me to the nearest Matigara Govt, Hospital. I was attended by the doctor on duty and after giving requisite treatment and after giving a injury report along with prescribed medications, I was allowed to left for my residence under the responsibility of Mr Harsh Kumar in the presence Of police personnel of Matigara Police Station. The aforesaid medical prescription described with the injuries is annexed herewith as Annx 'A' with this complaint.

Further I want to keep in your knowledge regarding certain incidents/facts which may be related to this incident, that, from 01<sup>st</sup> December 2018 to 20<sup>th</sup> August 2021, I had been employed and worked as Facility Manager for Uttorayan Residency Apartments Owner's association and I was forced to be under suspension from 20<sup>th</sup> August 2021. During the aforesaid tenure I was threatened by one Mr Sajjan Rateria Son of Late J P Rateria, residing at

HIG-080603, Uttorayan Residency Apartments Owner's association by using filthy language to harm me physically and for which, when I complained he seeks his apology in public platform of the aforesaid society through electronic media (WhatsApp). As there were some pre-existing disputes and for which I haven't been compensated, I agitated all the issues with the journalists club of Siliguri and subsequently the video recordings of the interview were circulated over different social media platforms as well as printed in the local newspapers. On 15<sup>th</sup> May as I could remember, the said Mr Sajjan Rateria served me a legal notice demanding Rs, 50,000,000.00 (Rupees Five Crores) in lieu of defamation and with a threatening for posting of a video by me through my Facebook account as well as other social media handler rendering unconditional apology towards said Mr Sajjan Rateria for posting the interview video. The legal notice dated 12<sup>th</sup> May 2023 drafted and signed by one Adv. Deborshi Dhar is annexed herewith and MARKED as ANNEXURE 'B' with this complaint.

I, therefore, requesting you to consider my complaint against the aforementioned accused persons and to initiate proper action as per the provisions of law, as my complaint prima facie indicating the involvement of racketeers who are a potential threat to the whole society and I would certainly not be the only victim of the aforesaid accused persons and it is indicating the psychological involvement dictating their criminal mentality.

Hence, most respectfully I am praying that adequate action must be initiated as soon as possible in the interest of justice and along with me the aforementioned accused persons may be investigated for the abovementioned offences as per the provisions vested with the law of the land.

As I am partially disabled and as my disabled daughter who witnessed the entire incident is in a severe mental trauma and moreover due to the assault I am physically unable to come personally. Hence, I request you to receive this complaint through my Advocate Mrs. Tanushree Karmakar, Registration No-F/1323/749/2016, Siliguri Bar Association keeping view of my aforementioned problems.
