Sir,

With due respect I **Smt. Usha Barman**, W/O Sri Niranjan Barman, Presently residing at of Medical More, Kawakhali, P.O. - Sushruta Nagar, P.S. - Matigara, District - Darjeeling, do hereby want to inform you as follows:-

1. That I was married to Sri Niranjan Barman, S/O Kesto Barman, residence of Rangapani, Dhujjote, P.O. - Ranidanga, P.S. - Bagdogra, District - Darjeeling, on 24.11.2014 and after the said marriage I started to live with my in laws at my matrimonial home at the above mentioned address and out of the said wedlock I had one daughter namely Hemanti Barman, who is now 8 years old.
2. That this is to inform you that after my marriage my husband and other in laws used to beat me mercilessly also used to torture me and my minor daughter mentally and physically. Subsequently on 04.06.2022, my husband throw me out of my matrimonial house along with my minor daughter and subsequently I took shelter at my parental house and finding no other alternative I lodged one F.I.R dated 06.06.2022 at Bagdogra Police station and one specific case was started against my husband and other in laws vide Bagdogra P.S. Case No. - 267 of 2022 U/S 498 A of I.P.C. dated 06.06.2022.
3. That subsequently my husband started to pressurize me to withdraw the said case otherwise he will kill me and my minor daughter. Thereafter all of a sudden my husband namely Niranjan Barman, S/O Kesto Barman, R/O Dhajujote, Rangapani, P.S. - Bagdogra, District - Darjeeling, came to my parental house on 05.06.2023 at about 09.00 A.M. and started to beat me mercilessly and also threatened me that if I did not withdraw the above mentioned case then he will kill me and my minor daughter. At this when I started to scream then my husband started to thrash my head in the wall and slapped me and also tried to kill me.

4. That thereafter when I started to scream and shout and the local people started to gather my husband fled away. Subsequently I was taken to Siliguri District Hospital for treatment. At present I am passing my days with a fear that at any time my husband may again come to my parental house and may kill me and my minor daughter.

Under the above mentioned situation I request you to kindly look after the above mentioned matter and take the necessary legal action as soon as possible to protect our life and dignity because at present I am living in a very dangerous situation as my prestige has already been destroyed by the acts of my husband.
