At present my labours are engaged in C.R.P.F. Camp, Kawakhal, since the month of February, 2023. One KULSUM BEGAM, daughter of Pailu Md, resident of Lenin Colony, P.O. Nema, P.S. Matigara, Dist. Darjeeling, who is one of the labours of abovemention company was engaged in work today i.e. 07.06.2023 at said C.R.P.F. Camp. At about 4:53 P.M. one MD. AFJAL, son of Md. Abbas, resident of Ward No. 13 Rajapur, Dist. Begusarai, Bihar, who is a J.C.B. driver working/hired by the aforesaid company, dashed said Kulsum Begam negligently due to his reckless driving. Suddenly said Kulsum Begam suffered greivous injury over her head. She was immediately rushed to the hospital by the other labours working there where the doctor of N.B.M.C. & H. declared her as dead.
