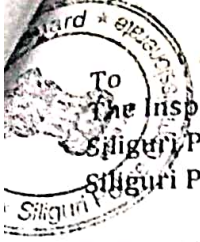

Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Panitanki More without any valid documents causing obstruction to public way.

Sir,

I SI Kamal Kr. Roy of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 07.06.23 around 18.35 hrs, while on duty at Panitanki More area found one TOTO without any registration number stationed Panitanki More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.


Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Mansur Ali(34 Yrs), S/O-Lt Baceha Muddin of Dandhy Gach, Das Para P.O- Das Para P.S-Chopra Dist- Uttar Dinaj Pur . At present address is Asraf Nagar, P.s- Bhaktinagar, Dist- Jalpaiguri . Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
