



- 1) That the complainant is a peace loving and law abiding citizen of India having permanent residential address as mentioned aforesaid and the complainant is a private employee by profession.
- 2) That the accused no. 01 is the legally wedded wife of the complainant their marriage was solemnized as per Muslim rites and customs and after marriage the above named accused no. 01 and the complainant started to live together as a husband and wife in a joint family along with complainant's brother namely, Md. Tammna and his sister-inlaw namely, Tamina @ Anima Khatun.
- 3) That after few days of their marriage the complainant noticed that the accused no.01 i.e. complainant's wife changed her behavior in respect of him as well as his my family members and the accused no. 01 him and his family members with dire always threatened consequences and told them that if the complainant and his family members try to interfere in her personal matters, then the accused no. 01 will call her relatives and they will kill the complainant and also told him that she will implicate the complainant and his family members in false cases.
- 4) That the complainant and his family members due to fear tolerated the inhuman activities of the accused person no. 01, with a hope that she will change her behavior in respect of complainant and his my family members but, such day never comes into the life of the complainant, however, during this period as per the instructions of the accused no. 01, the other co-accused i.e. accused no. 02 to 05 came to the complainant's house and assaulted the complainant and his family members with fist and blows and also destroyed their house and took away some valuable items from their house, but the complainant and his family members did not inform the said matters to any authority L& Declarcause the accused no. 01 always threatened and told them that she ntification will implicate them in false cases so, out of fear the complainant and

his family members did not lodge any complaint against them. I MODAK

of Indial respondent to mention here that ultimately, on 25.04.2023, the above named accused persons i.e. accused no. 01 to 05 came to the complainant's house at about 10:00 am after making some criminal conspiracy as per the instructions of the accused no. 01, i.e. the complainant's wife, used slang languages towards the complainant

and his family members and when the complainant and his family members protested the same at that time they all of them i.e. the accused no. 01 to 05, started to assault the complainant and his family members and they had also carried knife and one sharp cutting weapon (Vojali) and with help of said weapons they put the complainant and his family members in fear of death and after putting them in fear of death and with help of aforesaid weapons they committed robbery from the complainant's house and took a sum of Rs. 22,000/- (Rupees Twenty-Two thousand) only, which was lying in the wardrobe and also they took one finger gold ring from the complainant's hand and also destroyed the complainant's house very badly, after the aforesaid incidents the above named accused persons i.e. accused no. 01 to 05 left the complainant's house and during that period the accused no. 01 also threatened the complainant and his family members with dire consequences and told them that if the complainant lodge any complaint against the above named accused persons then the accused no. 01 will file false cases against the complainant and his family members.

- 7) That on 22.05.2023, the above named accused persons once again came to the working place of the complainant, near Mahanada River, Airview More, Siliguri, at about 3:30 pm and they once again started to assault the complainant with fist and blows in presence of the complainant's friends and also threatened your complainant with dire consequences and due to the aforesaid criminal activities of the above named accused persons the complainant and his family members spending their days in very bad conditions.
- 8) That thereafter no other alternative way your complainant on 31/05/2023, lodged a written complainant before the commissioner of police, Siliguri police commissionarte but till today no action has been taken against them by any concern authority / police.

That this complaint is made bona fide and for the ends of justice.

Under the above facts and circumstances, it is, prayed that Your Honour would graciously be pleased to consider this application u/s 156(3) of Cr.P.C directing I/C, Siliguri Police Station to treat this complaint as F.I.R and to start a specific case against the accused persons under proper sections of law and to investigate the case properly and sincerely or to pass such other order/orders as Your Honour may deem fit and proper for the ends of justice.
