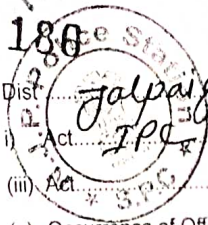

Sub: → Lodging FIR against physical assault and harassment.

Sir, This is to kindly inform you that on 5/6/2023 at 15:30 hrs there was a minor incident of quarrel among two children. Then as a result of that small quarrel a panchayat meeting was called at West Doytola, Fulbari. During that meeting a sudden attack was made on my brother and father, both of them were badly beaten in front of the panchayat president, Mr. Rafique during the meeting.

Then they forcibly entered our house and brutally assaulted me. The names of persons who assaulted me are, Bishal, Purnu, father of Raja, Sujata, Rina, Gopal, others of the area, whom I can identify if required. Such physical assault on a woman by many men is not expected when the honorable CM of the state is a female. A FIR may immediately be lodged and early action is solicited. Medical report of doctor is also given and registered.
