Sub:- That My daughter Kanan Roy Barman wife of Krishna Roy committed suicide on 06/06/2023 at her parental house Bhupendra Nagar, salugara ward No 42, under SMC, Jalpaiguri.

Sir,  
This is to bring into your kind attention that my daughter Kanan Roy Barman wife of Krishna Roy and mother of two children namely 1. Tapesri Roy aged 10 years and 2. Ankit Roy aged about 8 years.

That yesterday on 06/06/2023 at around 11:30 Am and 12:20 Pm my daughter committed suicide by consuming Poison.

That my daughter got married in the year 2011-2012 with Kanan Roy Barman and thereafter from the wedlock of said marriage they had two children Namely **1. Tapesri Roy aged 10 years studying in Shri shri Vidya Mandir in class 4 and 2. Ankit Roy aged about 8 years also studying in Shri shri Vidya Mandir class 2.**

That soon after the birth of the second child my son in law used to beat my daughter and used to heckle her for money, that time and again my son in law would force my daughter and her children out of his house by assaulting her and abusing her.

That having no recourse my daughter used come to our house that is her parental house with both her children in Bhupendra Nagar, salugara ward No 42, under SMC, Jalpaiguri. That in past several meetings between both the families took place to reconcile the matter but it was only beneficial for some time. That my son in law during the first lockdown in 2020 came to visit in month of march my daughter and took her along with him and his younger son. That in the presence of her younger son my son in law used to beat my daughter in law with various objects for no reason. That finally after suffering a lot of abuse for various reasons and mainly because of money and dowry that my daughter finally came back in the month of October Novemebr 2020.

That in the meantime my daughter and son in law where in telephonic conversations and my daughter used to call him on a regular basis

That my son in law used to still abuse her on calls and in these many years he never visited even once to see her neither he visited to look after his children.

That my son in law and his family members; i.e

1. Father of my son in law **Saren Ray.**
2. **Mother of Son in law Uli Ray**
3. Elder brother of My Son In law Bidya Roy were also similarly engaged and being part of in this abuse as they would collectively would abuse her and would take turns in telling her that "she is worthless and rather she(my daughter) should kill herself as she didn't bring any valuables with her post her marriage"( Dada sami sasur sasuri

That post her marriage my daughter took a lot of goods and commodities as per the demands of her in laws, Like Sewing machine, Money for Buying Motorcycle Pulsar 150, Gold ornaments to my son in law namely GOLD RING.

That My son In law has never taken care of my daughter nor his children till date, that my daughter used to work in daily households for meeting her expenses and the needs and requirements of here children. That finally on 04/06/2023 she went to meet her husband at her matrimonial house In **Fulbari Ghatamar Bari, Jalpaiguri 734015** in the evening and stayed there and returned to Salugara BhUpendra nagar on 5/06/2023. That on 06/06/2023 when I Anima Barman Wife of Chitro Barman I was in Bhaktinagar Police Station from 10:30 Am to 12:10 Pm with Sabitri rai, Kabita rai, Geeta Rai because we had to meet Officer Gopesh Barman because of some reason related to children of our Locality Dulal and Subho who also met with Officer Gopesh Barman. That during those hours when I was not with my daughter she consumed the poison in presence of her two children **1. Tapeshri Roy aged 10 years and 2. Ankit Roy aged about 8 years**, and local people of our para took her in a car to Siliguri Civil Hospital at venus more but they didn't admit her and later she was taken To North Bengal Hospital at medical where she was admitted and her initial treatment for recovery was initiated by the Doctor in charge at that time, the said treatment of her recovery started at around 2:00PM in NBMC & H North Bengal medical College and Hospital.


That around 9:30 Pm on 06/06/2023 my daughter Kanan Roy Barman gave a declaration to my **Second daughter Taposhi roy** that my deceased daughter was forced to consume poison by her in laws and her husband Krishna Roy Barman, That she stated Krishna Roy Barman bought the poison and gave to my daughter and in her dying breathe she stated that her husband told her "**Amar Jeevanei Tor Dorkar Nai, Tomake ami nij thike Vish kine dibo tui ota khaye mor**". That 9:30 Pm my daughter expired cause of the poison she took.

That Krishna Roy barman the husband of my daughter instigated her to take poison and forced her to take poison.

That I had informed the in laws on 06/06/2023 about the said incident, they came and visited her and left that post the demise of my daughter when I called them today on 07/06/2023 in the morning to ask them to come for the rituals and rites but they outright rejected from visitation by saying we have no role to play.

That it is to draw your attention to the fact that my daughter's in laws and her husband has instigated and forced her to commit suicide and I request your good self to take stringent legal actions.
