In producing herewith five arrested accused persons including one lady namely (1) Barun Roy-33yrs s/o Lt Tarun Roy of Iskcon Mandir road near Kali Mandir, ward No-40, PS Bhaktinagar Dist Jalpaiguri (2) Samir Sarkar-35yrs S/o Lt Hari Charan Sarkar of Ghugumali Fol Bazarroad near Junior sangha club ward no-37, PS Bhaktinagar Dist Jalpaiguri (3) Prasanta Dey @ Sanju-31yrs s/o Litan Dey of Sukantanagar Auto stand, near Janakalyan Ashram, Ward No- 38, PS Bhaktinagar Dist Jalpaiguri (4) Md Ahamad @ Vodu-30yrs s/o Md Abdul of Asrafnagar PS Bhaktinagar Dist Jalpaiguri (5) Nurja Begam @ Vaji-30yrs w/o Jahir Sha of Asrafnagar PS Bhaktinagar Dist Jalpaiguri along with the following seized articles under seizure as per seizure list:

It is reasonably believe that the persons possessing the Injection may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 327 dated 07.06.23 and informed I/C Bhaktinagar in written about the plan of action. Thereafter myself along with SI Srimanta Chatterjee, ASI Dipak Karmakar, C/1430

Dilip Barman, C/374 Debraj Biswas, C/915 Chandra Prakash Adhikary, L/C 1584 Rupni Oraon and L/C 1212 Nitita Lama all of Bhaktinagar PS taking blank paper, wax, metal seal and knife and other investigation kits left for Eastern bypass Near mandal Petrol Pump to work out the information vide Bhaktinagar PS GDE No-328 dated 07.06.23 & MCC No-01 dated 07.06.23.

At 16.25 hours I along with officer and force reached at Eastern bypass, near Mondal petrol pump and contacted the source who show us those persons from a certain distance, I briefed all Officers and force to cordon the persons as tactful as possible in order to thwart their escape from the scene. Meanwhile I called two independent witnesses namely 1) Tapas Barman-31yrs s/o Kaylash Barman of 22 Guri, Bora Kamardara PS Mathabhanga Dist Cooch Bihar at present C/o Tapas Hotel near Mondal petrol pump Eastern bypass PS Bhaktinagar Dist Jalpaiguri and (2) Monjit Roy-27yrs s/o Lama Roy of Chayanpara Ray colony more, PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received requested them in written to remain present with us during search and seizure and also called one Videographer namely Nitai Chowdhury of Shivarampally, Haiderpara, PS Bhaktinagar Dist Jalpaiguri with a request to record the whole process. We rounded them up and questioned about their name and address when they disclosed their identity as above. On interrogation about the drugs, initially did not disclose anything about this. I forced them to open it, when they disclosed that huge no's of injections belong to them. On further interrogation they disclosed that they procured the illegal injections from siliguri to deliver the same to their customers'. Then I detained them and gave an option in writing whether they are willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that they are willing to be searched in presence of Executive Magistrate. Then I informed Sri Rajen Chhetri, Assistant Commissioner of Police, (DD) SPC as Special Executive Magistrate to come at the PO requested him to presence during search and seizure of the injections.

At 18.05 hrs Sri Rajen Chhetri, Assistant Commissioner of Police, (DD) SPC arrived at spot. Thereafter I opened one dickey of one scooty and found illegal injections inside. I asked the accused persons above named to produce document if any in support of possessing such a huge quantity of injections with him but they failed to produce any document. I seized the following articles under proper seizure list in presence of witness under direct supervision of Sri Rajen Chhetri, Assistant Commissioner of Police, (DD) SPC under proper labeling.

NATURE OF ARTICLES SEIZED

- (1) 70 (seventy) pcs of promethazine Hydrochloride injection IP (PHENERGAN) having composition hydrochloride IP 25mg and marked as Exhibit-A
- (2) One piece of promethazine Hydrochloride injection taken out as sample from Exhibit-A and marked as Exhibit-A1
- (3) 70 (seventy) pcs of Buprenorphine injection IP (LUPIGESIC) having composition Buprenorphine Hydrochloride IP equivalent to Buprenorphine 0.3mg and marked as Exhibit B
- (4) One pcs of Buprenorphine injection IP (LUPIGESIC) taken out as sample from Exhibit-B and marked as Exhibit-B1
- (5) 70 (seventy) pcs of DIAZEPAM injection IP having composition Diazepam IP 5mg and marked as Exhibit-C

(Seizure was made in between on 07.06.23 in between 18.15 hrs to 19.25 hrs)

Under the above circumstances it is evident that the accused persons above named procured have committing offence under NDPS act. On interrogation accused persons confessed their guilt and stated that they were doing such kind of business illegally with any valid documents/License since long for his wrongful gain. It is crystal clear that the accused persons are peddling prescription drugs meant for the sick peoples to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested them u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper memo of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Barun Roy-33yrs s/o Lt Tarun Roy of Iskcon Mandir road near Kali Mandir, ward No-40, PS Bhaktinagar Dist Jalpaiguri (2) Samir Sarkar-35yrs S/o Lt Hari Charan Sarkar of Ghugumali Fol Bazarroad near Junior sangha club ward no-37, PS Bhaktinagar Dist Jalpaiguri (3) Prasanta Dey @ Sanju-31yrs s/o Litan Dey of Sukantanagar Auto stand, near Janakalyan Ashram, Ward No- 38, PS Bhaktinagar Dist Jalpaiguri (4) Md Ahamad @ Vodu-30yrs s/o Md Abdul of Asrafnagar PS Bhaktinagar Dist Jalpaiguri (5) Nurja Begam @ Vaji-30yrs w/o Jahir Sha of Asrafnagar PS Bhaktinagar Dist Jalpaiguri also arrange for its investigation.
