Subject: Written Complaint against one Uttam Singh, s/o unknown, resident of Ethelbari, Dist. Alipurduar and his associates.

Sir,

I, Buddhi Roy, wife of Rotash Kumar, resident of Salugara, Bikash Nagar, Dist. Jalpaiguri would like to lodge a written complaint to the effect that ^{07/6/23} approximately at around 3.30 p.m., when me and my husband were at our home, my husband received a phone call on his mobile (being mobile no. 8250846396) from an unknown number (being mobile no. 6297981994) and over phone call, one unknown person said to my husband that he is a man of one Uttam Singh (who is known to my husband), s/o unknown, resident of Ethelbari, Dist. Alipurduar and Mr. Uttam Singh has asked my husband to show to such unknown person a saleable property situated at Limbu Basti and thereafter my husband along with one Soumalya Roy (friend of my husband) left the home.

That subsequently approximately at around 5.30 p.m. when I ringed my husband on his mobile number, his phone was switched off and thereafter when I ringed Soumalya Roy, he informed me that at around 4.20 P.M. when my husband and Sri Soumalya Roy were present opposite to Radio Center, Sevoke Road, suddenly 5 (five) unknown persons arrived a four wheeler vehicle (Mahindra Xylo) and who claimed themselves to be the associates of Uttam Singh blatantly abused my husband in most vulgar language and brutally hit on his back portion of his head with an article which was black in colour (exactness of which Soumalya Roy could not identify properly) causing him extreme pain and blood loss and forcibly kicked him inside the aforesaid vehicle and threatened him and Soumalya Roy with dire consequences that if either of them inform about the said incident to any other person or law enforcement agencies Uttam Singh will not hesitate in taking away the life and liberty of the said persons and their family and thereafter from the said spot associates of Uttam Singh on his direction abducted my husband and forcibly took him along with them in the aforesaid vehicle.

It is pertinent to mention here that even on previous occasions my husband had told me that Uttam Singh is threatening him and his life is in danger and to give effect to the same Uttam Singh along with his associates by hatching a conspiracy against my husband in collusion and connivance with each other abused and beaten my husband and abducted him.

Therefore, I humbly request your esteemed authority to take strong and deterrent action against Sri Uttam Singh and his associates as per the relevant laws of the land.
