requested him several times for a sober living with me or providing maintenance for me and our child regularly. But my husband is still mistreating with me and making me victimised to suffer mental and physical pain by ignoring and avoiding all his duties and liabilities as much as expected from a husband. His mother is equally involved in everything whenever I talk to him over phone, he starts using slang languages with threatening that being a silly woman I am unable to do anything against his will and so, he never cares about my sufferings and nor does his mother.

Presently, I am living with utter pain both mentally and physically along with my child of 3 years at my parental house. I have no source of income than depending on my old father. My husband is not providing me any kind of maintenance. He is also not ready to allow me to stay together with him nor is ready to provide any kind of maintenance for my son. Recently, he is threatening me over phone being NO-+818047431405 that he would kill me and would not pay me a single rupee nor allow me in his life again and I cannot do anything against his will for he is staying in Gopan now. On 4th of June, I called him over phone about my unbearable sufferings but he did not care rather started scolding me very arrogantly.
