Sir,

With due respect and humble submission, I SI Swadesh Saha of Ambari Falakata OP, under NJP PS, SPC beg to lodge this written complaint that today on 08/06/2023 myself along with C/789 Paban Sarkar and NVF/ 131 Bidhan Roy were detailed to perform Morning Mobile Van Duty w.e.f. 07:57 hrs to 14.00 hrs with Govt. vehicle Vide MCC No.1220/2023 Dated: 08.06.2023. At about 09:45 hrs, duty officer ASI Rana Jadav informed me that an accident took place on Ambari to Paramunda Road near by Chelibari Bazar under Ambari-Falakata OP and also requested me to look into the matter. This refers to Ambari-Falakata OP GDE No. 279, Dated: 08.06.2023. Accordingly, myself along with above noted force rushed to Ambari to Paramunda Road near by Chelibari Bazar and reached there about 10:55 hrs. We found that a huge traffic jam on this road where ambulance, defense vehicle, VIP vehicles, passenger vehicles and dumper were stuck. On being asked one local shop owner of Chelibari Bazar stated that one school girl namely Riya Roy(11yrs), D/o. Sanjit Roy of Chhatmalanigachh, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri was dashed by some unknown vehicle. Over this she received injury and shifted to Maya Sanyal Nursing Home Siliguri and now her condition is stable. Immediately myself along with force intervene the matter and trying to control the mob. On that occasion an Unruly mob more or less 30 persons pelting stone on the vehicles which were stuck in this road. We tried hard to stop them but the mob attacked us and started scuffling with us. I informed the matter to O/C Ambari-Falakata OP over telephone and also requested him to provide re-enforcement immediately. In the meantime unruly mob tried to set fire on a Dumper. In the meantime re-enforcement team consisting of SI PR Bhutia, SI Rakesh Debnath, ASI Kajal Chakraborty along with other officers and forces reached at the spot. We all tried hard to control the situation. We all tried to clear the road but said mob started pelting stone upon us to discharge our Govt. duty. As a result our vehicle driver CV-963 Tapan Roy sustained severe injury over his forehead caused by pelted stone and immediately shifted him to Rajganj Rural Hospital where doctor gave him two stitched and advice him for take rest. In-spite of that ASI. Kajal Chakraborty, C/-789 Paban Sarkar also received severe injury. Lastly, finding no other alternatives we chased over the unruly mob and thus the situation came under control and in the mean time we success to arrest one person namely Paritosh Roy(25yrs), S/o. Kahalal Roy of Bashbari, PO. Kundardighi, PS. Rajganj, Dist-Jalpaiguri who is directly involved to create this incident where common people suffers a lot.

Therefore, I pray before your kind honor that a specific case under proper section of law may kindly be started against Paritosh Roy(25yrs), S/o. Kahalal Roy of Bashbari, PO. Kundardighi, PS. Rajganj, Dist-Jalpaiguri and others for its investigation.
