**F.I.R. AGAINST PRADIP DAS & DIPU DAS FOR PHYSICALL ASSAULT & THREATENING**

Respected Sir,

I, Sri Ramashankar Karmakar, S/o. Late Murat Karmakar aged about 80 years, R/o. Ho-Chi-Min Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, would like to state that yesterday i.e. on 06-06-2023 at about 8.00 P.M. when my son namely Arjun Karmakar was changing tyre of his vehicle near my house suddenly two persons namely (1) PRADIP DAS & (2) DIPU DAS, Both sons of Pramod Das, R/o. Lala Busty, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, suddenly attacked my son Arjun Karmakar without any reason. When I heard hue & cry of my son I came outside and saw that (1) PRADIP DAS & (2) DIPU DAS were beating my son mercilessly.

I interfere in the matter and tried to know the fact about why PRADIP DAS & DIPU DAS were beating my son, but PRADIP DAS & DIPU DAS without listening me caught hold of me and physically assaulted me also. I am a senior citizen aged about 80 years and I tried my best to solve the issue but PRADIP DAS & DIPU DAS were in dangerous mood and they came with intention to kill my son and me. Due to their assault I sustained injuries.

They were using slang language to me & my son. They were so adamant that they kept on threatening me & my son in front of my house. I & my son anyhow managed to get rid of their cruel hands and came inside of my house and locked the gates due to their fear. Finding no other option I came before you. If he is not restricted then they might created a big problem future. I am an aged person with various ailments and at this age I am unable to resist them hence I came before you for justice.

It is requested before you in folded hand to kindly take strict necessary action against (1) PRADIP DAS & (2) DIPU DAS so that they can be punished.
