Respected Sir,

I, ASI Ganapati Bagdi, of NJP Traffic Guard, SPC, presently conducting the Traffic Regulation duty at Base Hospital more under Bagdogra Traffic Guard, beg to lodge a written complaint that on 07.06.23 around 10:45 am 01(one) toto vehicle without any registered number is coming from Bihar More side carrying 05 passengers, on Service Road, near Base Hospital More the said toto over turned while change the flank due to rash driving of toto driver. Out of them 02 passengers of the said toto was injured.

According I ASI Ganapati Bagdi of NJP Traffic Guard, along with C/1544 Manoj Chowdhury of Balason TOP had been present at Base Hospital More, and informed to the Local police Station, after that the toto driver with toto hand over to the local Police van officer. After some time disclosed the toto driver name as Himanshu Srivastav, (Age-26 yrs), S/O- ashok Srivastav of Surya Nagar, Lower Bagdogra, Tiger Basti, Bagdogra PS-Bagdogra , Dist- Darjeeling, Pin- 734014 Mob-8942986886.

Further on being asked him to produced relevant documents in support of his claim of plying toto on National Highway, but he failed to produce the same. Hence he committed the cognizable offence disturbing the free flow of vehicular of traffic and endangering the life and free movement of public in general. Thereafter I also seized the toto from his possessions after preparing proper seizure list u/s 102 Cr. P.C in presence of local witness and duly attested by him and took into custody. Hence I would therefore request you to kindly start a specific case under proper section of law against above noted Toto driver and oblige.
