Sir,

I ASI Anupam Roy of NBMC OP, under PS Matigara, SPC producing herewith one arrested accused person namely Pankaj Roy (M-26 yrs) s/o Tilak Roy of Pelkujote, PS Matigara, Dist. Darjeeling, along with Memo of arrest, and lodged this Police complaint against him and the below noted accused persons, to the effect that, today on 09/06/2023 evening I ASI Anupam Roy along with ASI Dulal Dey, Constable 1085 Mithun Debnath, Constable-374 Badi uz zama iski, Constable-340 Pronab Adhikary, and CV-638 Partha Biswas were performing evening raid duty at Pelkujote under PS Matigara. Vide NBMC OP MCC NO-752 dated 09/06/2023, and when we reached at village Pelkujote, we found that some persons were consuming alcohol, at a public place near Pny School of said village. As such we chase to apprehended them, at that time the above noted accused person named Pankaj Roy s/o Tilak Roy, Sampad Roy S/O Tilok Roy, Smt Kabita Roy W/O Sri Tilok Roy along with some others of Pelkujote reached there and raised objection regarding arrest the accused persons, and also assaulted us to deter us from discharge of our Govt. duty. We managed to arrest accused Pankaj Roy s/o Tilak Roy of Pelkujote, PS Matigara, Dist. Darjeeling and others were fled away from the spot.

Under the above circumstances, I am submitting this written complaint against the above accused person namely Pankaj Roy s/o Tilak Roy, Sampad Roy S/O Tilok Roy, Smt Kabita Roy W/O Sri Tilok Roy along with some others for starting a specific case under proper section of law and to arrange for its investigation.
