Sir,


I SI Prokash Saha of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 10.06.23 around 18.40 hrs, while on duty at 9/10 crossing area found one TOTO without any registration number stationed 9/10 Crossing in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Suman Halder(42 Yrs), S/O-Ratikanta Halder of Malkel madhusudhan Colony, Sahudangi hat, Kamarvita P.S-New Jalpaiguri Dist- Jalpaiguri . Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
