Sir,

In producing herewith one arrested accused person namely Dinabandhu Barman(35) S/O- Dilip Barman of Goyal Jote, Nimai Jote, P.S- Matigara, Dist-Darjeeling, along with one seized vehicle bearing no WB- 76/A-9340(Dumper)loaded with river bed materials under proper seizure

I, SI Basudeb Guha S/O Lt. Badal Ch. Guha of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against one namely Dinabandhu Barman(35) S/O- Dilip Barman of Goyal Jote, Nimai Jote, P.S- Matigara, Dist-Darjeeling, the driver of Seized vehicle bearing no- WB- 76/A- 9340(Dumper) loaded with river bed materials to the effect that today on 10.06.2023 at 22.35 hrs received a specific source information that one vehicle bearing no- WB- 76/A- 9340 (Dumper) loaded with river bed materials had been moving along the high way towards Jalpaimore. Accordingly I informed the matter to the I/C PS and being directed by the I/C PS myself along with assisting force left PS to verify the veracity of source information. On the way towards Jalpaimore I detained a vehicle bearing no- WB- 76/A- 9340 (Dumper), loaded with river bed materials, at Balason River and also apprehended the driver of the said vehicle who on being asked disclosed his identity as Dinabandhu Barman(35) S/O- Dilip Barman of Goyal Jote, Nimai Jote, P.S- Matigara, Dist-Darjeeling. On demanded he failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing no- WB- 76/A- 9340 (Dumper) stated that he is involved in carrying of river bed materials by illegal means for his wrongful gain since last few months without consent of his owner namely Smt. Sukla Kundu . Accordingly I seized the vehicle bearing no- WB- 76/A- 9340 (Dumper), being loaded with river bed materials and subsequently arrested the driver named Dinabandhu Barman(35) S/O- Dilip Barman of Goyal Jote, Nimai Jote, P.S- Matigara, Dist-Darjeeling. The whole process of seizure and arrest was made in between 23.25 hrs to 23.45 hrs

Hence, I pray that a specific case may kindly be started against the driver namely Dinabandhu Barman(35) S/O- Dilip Barman of Goyal Jote, Nimai Jote, P.S- Matigara, Dist-Darjeeling, of above noted vehicle bearing no- WB- 76/A- 9340 (Dumper), loaded with river bed materials under proper section of Law and arrange for its investigation.
