Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Kewal Roy (35) s/o Lt. Manglu Roy of Gorarbari, near Mamtapara, PS- New Jalpaiguri, Dist.- jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 21 (Twenty One) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)
2. 05 (Five) bottles of strong Kingfisher Beer containing 650 ml in each bottle.
3. 11 (Eleven) Bottles of 70 Upo Himalayan Fata Fati country spirit containing 300 ml. in each bottle.

I, SI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that on 09.06.2023 at 2135 hrs I received a secret source information that one person namely Kewal Roy (35) s/o Lt. Manglu Roy of Gorarbari, near Mamtapara, PS- New Jalpaiguri, Dist.- jalpaiguri is selling ID liquor illegally at his shop at Gorarbari, under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 467 date: 09.06.2023 and informed the fact to you. As per your kind direction and instruction myself along with ASI-Dhruba Mishra, C/453 Uttam Roy & VP/13 Jamirul Islma all of NJP PS, SPC left for Gorarbari, near Mamtapara, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 2155 hrs we arrived at the shop of Kewal Roy, Gorarbari, near Mamtapara under New Jalpaiguri PS, Dist.- Jalpaiguri and being identified by the source I held raid at the shop where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During raid the persons who were taking liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2215 hrs to 2245 hrs on 09.06.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kewal Roy (35) s/o Lt. Manglu Roy of Gorarbari, near Mamtapara, PS- New Jalpaiguri, Dist.- jalpaiguri and arrange for its investigation.
