Sir,
I, BHARATI MANDAL, wife of Sri. Kishor Mandal, resident
of South Shantinagar, Anandapally, P.O. Dabgram No. 2, P.S.
N.J.P. Dist. Darjeeling, would like to inform you that as
follows:-

1. That my husband KISHOR MANDAL, son of Lt. Mangal Mandal,
is a Private Pandal Decorator, working at a hired basis.
One JAGADISH DAS @ POCHA, s/o Unknown, r/o. Bari Bhasa,
Bhamesh more, P.O. Sahudanghat, P.S. N.J.P., Dist. Jalpaiguri,
who is a Pandal Head Decorator, hired my husband
in the month of January, 2023, at Hazira basis for one
of his site.

2. That my husband, despite of his aforesaid work, was
unpaid by said JAGADISH DAS. Said JAGADISH DAS promised
that he shall pay the total outstanding hazira Rs. 4,000/-
to my husband within few months but in vain. Again
a week ago said JAGADISH DAS again hired my husband
for his work and promised he shall pay off his
outstanding Haziras and he shall also pay his
haziras for his current work. My husband reluctantly
accepted his proposal with a hope that said JAGADISH
DAS, might pay off his haziras altogether and also we
were going to a cute financial crisis.

3. That on 08.06.2023 at about 9:30 P.M. I and my
husband visited him at his house and asked and
requested him to pay off his all outstanding dues
to us i.e. Rs. 4,000/- but he and his son became
ferocious and started to hurl abuses against us. His
son SUJAN DAS, son of Jagadish Das, assaulted my
husband with 1 1/2 feet concrete waste at his back
and said JAGADISH DAS assaulted him with a
sharp weapon on his persons, both were saying that
"TODAY WE WILL KILL YOU. NO ONE CAN STOP US". I started
to cry out loud and then the local people rushed into
the spot and rescued me and my husband. They
threatened that "NEXT TIME IF YOU BOTH COME AND ASK
MONEY OR IF YOU BOTH COME AT SIGHT. WE SHALL KILL
YOU WITH NO FAIL". Now my husband is under treatment
at SILIGURI CIVIL HOSPITAL and is in serious condition.

I therefore request you to kindly take necessary
legal steps against 1. JAGADISH DAS @ POCHA and 2. SUJAN DAS and
thus obliged.
