Sir,

In producing herewith one arrested accused person namely Jayanta Saha(56yrs) S/o. Lt. Jitendra Nath Saha of Ambari-Falakata, PO-Kamarvita, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10(Ten) sealed Bottles of Galaxy Boss 60 UP Country Sprit containing 600 ML each.
2. 05(five) sealed bottles of Kingfisher strong premium Beer containing 650 ML each.
3. 02(Two) nylon bag.

I, ASI. Kajal Chakraborty of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 10.06.2023 at 16:25hrs received a source information from Telenipara, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at the side of Telenipara main road who was carrying above noted to selling the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE No. 355 dated 10.06.23. I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) C/505 Tapash Dutta and (2) C/975 Swarup Basak both of Ambari-Falakata OP, Under NJP PS/SPC proceed to Telenipara under Ambari-Falakata OP to work out the information. At 16:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the side of Telenipara area main road of the above noted person, situated at Telenipara and recovered the above noted articles from the possession of accused person namely Jayanta Saha(56yrs) S/o. Lt. Jitendra Nath Saha of Ambari-Falakata, PO-Kamarvita, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses namely (1) Abhijit Majumder S/o. Lt. Ashim Majumder of Mahamaya Colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri and (2) Baban Prasad S/o. Sohan Prasad of 09 No. Colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri The seizure was made between 17:05 hrs to 17:45 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Jayanta Saha(56yrs) S/o. Lt. Jitendra Nath Saha of Ambari-Falakata, PO-Kamarvita, PS-NJP, Dist- Jalpaiguri under proper section of law.
