2. 13 (Thirteen) Bottles of 70 Up Himalayan Fata Fati country spirit containing 300 ml. in each bottle.

I, ASI-Dhruba Mishra presently attached with NJP PS under your kind control beg to state that on 10.06.2023 at 2115 hrs I received a secret source information that one person namely Krishna Roy (3) s/o Lt. Rashik Roy of Baribhasa, Madani Bazar, PS- New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Baribhasa, Madani Bazar, under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 517 date: 10.06.2023 and informed the fact to you. As per your kind direction and instruction myself along with ASI-Khagen Barman, C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for Baribhasa, Madani Bazar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 2135 hrs we arrived at the shop of Krishna Roy (3) s/o Lt. Rashik Roy of Baribhasa, Madani Bazar, PS- New Jalpaiguri, Dist.- Jalpaiguri and being identified by the source I held raid at the shop where the above noted accused person selling ID Liquior.
