Sir,

In producing herewith one arrested accused person namely (1) Mithun Ghosh (M/32yrs) S/O- Madhab Ch Ghosh of Kasba, P.O- Mirual, P.S- Raiganj, Dist- Uttar Dinajpur along with the following seized articles under seizure as per seizure list:

I SI Rantu Haldar S/O- Monoranjan Halder of Bhaktinagar Police Station, under Siliguri Police Commissionerate after producing one arrested accused person namely (1) Mithun Ghosh (M/32yrs) S/O- Madhab Ch Ghosh of Kasba, P.O- Mirual, P.S- Raiganj, Dist- Uttar Dinajpur along with seizure articles (1) One transparent Packet containing said to be Ganja weighing approx 7Kg 325grm and marked as Exhibit-A (2) One transparent Packet containing said to be Ganja weighing approx 8Kg 428grm and marked as Exhibit-B (3) One navy blue colour trolley bag styled as "Arya" do hereby lodged written complaint to the effect that on 10.06.23 at 11.40 hrs received reliable source information that one person coming from Birpara to Siliguri PC Mittal Bus terminus and standing at PC Mittal Bus terminus under Bhaktinagar PS with a huge quantity of narcotics Substances to deliver the same to his designed customer. It is reasonably believe that the person possessing the narcotics Substances may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 465 dated 10.06.23 and informed I/C Bhaktinagar in written about the plan of action. Thereafter myself along with, ASI Dipak Karmakar, C/1430 Dilip Barman, C/374 Debraj Biswas, all of Bhaktinagar PS taking blank paper, wax, metal seal and knife and other investigation kits left for PC Mittal Bus terminus to work out the information vide Bhaktinagar PS GDE No-466 dated 10.06.23 & MCC No- 776 dated 10.06.23.

At 12.05 hours I along with officer and force reached at PC Mittal Bus terminus and contacted the source who show us those persons from a certain distance, I briefed all Officers and force to cordon the person as tactful as possible in order to thwart their escape from the scene. Meanwhile I called two independent witnesses namely 1) Kamal Roy (M/47) S/O- Lt Rambrij Roy of Champasari Anchal. P.O- Dabgram, W.No-46, P.S- Pradhan nagar, Dist- Darjeeling and (2) Santosh Singh (M/44) S/O- Brij Kishor Singh of Gandhi nagar, W.No- 43, PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received requested them in written to remain present with us during search and seizure and also called one Videographer namely Nitai Chowdhury of Shivarampally, Haiderpara, PS Bhaktinagar Dist Jalpaiguri with a request to record the whole process. We rounded him up and questioned about his name and address when he disclosed his identity as above. On interrogation about the Narcotic Substances, initially did not disclose anything about this. I forced him; after that he disclosed that huge quantity of Ganja belong to him. On further interrogation he disclosed that he procured the illegal Ganja from Birpara to deliver the same to his customers. Then I detained him and gave an option in writing whether he is willing to

be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Executive Magistrate. Then I informed Sri Gyalchen Lepcha, Assistant Commissioner of Police, (Traffic HQ) SPC as Special Executive Magistrate to come at the PO requested him to presence during search and seizure of the injections.

At 13.45 hrs Sri Gyalchen Lepcha, Assistant Commissioner of Police, (Traffic HQ) SPC arrived at spot. Thereafter I opened the bag and found Ganja inside. I asked the accused person above named to produce document if any in support of possessing such a huge quantity of Ganja with him but he failed to produce any document. I seized the following articles under proper seizure list in presence of witness under direct supervision of Sri Gyalchen Lepcha, Assistant Commissioner of Police, (Traffic HQ) SPC under proper labeling.

#### NATURE OF ARTICLES SEIZED

- (1) One transparent Packet containing said to be Ganja weighing approx 7Kg 325grm and marked as Exhibit-A
- (2) One transparent Packet containing said to be Ganja weighing approx 8Kg 428grm and marked as Exhibit-B
- (3) One navy blue colour trolley bag styled as "Arya"

(Seizure was made ~~in between~~ on 10.06.23 in between 13.55 hrs to 14.35 hrs)

Under the above circumstances it is evident that the accused person above named procured have committing offence under NDPS act. On interrogation accused person confessed his guilt and stated that he was doing such kind of business illegally with any valid documents/License since long for his wrongful gain. It is crystal clear that the accused person is peddling Ganja meant for the sick peoples to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested him u/s 41 Cr.P.C. after explaining him about the ground of arrest issuing proper memo of arrest. Arrested accused person along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused person namely (1) Mithun Ghosh (M/32yrs) S/O- Madhab Ch Ghosh of Kasba, P.O- Mirual, P.S- Raiganj, Dist- Uttar Dinajpur also arrange for its investigation.
