Sir,

In producing herewith one female accused person namely (1) Smt Ujjala Saha (56), W/O-Late Bimal Saha of Purba Hatiadanga, Near Egg Godowns PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

(1) 16 (Twelve) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.155/- (Total- 9.6 Liters & Amount Rs 2480/-).

I SI Pradip Kr Singha of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely (1) Ujjala Saha (56), W/O-Late Bimal Saha of Purba Hatiadanga Near Egg Godowns PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 11.06.2023 at 14.05 hrs as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath, ASI/ 877 Munna Ahmed, C/970 Bikash Roy and L/C 1234 Hira Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti-social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 250 Dt.11.06.2023 in course of which I received information from my source that one Smt Ujjala Saha stored a huge numbers of bottles of liquor inside her house at Purba Hatiadanga Near Egg Godowns and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Purba Hatiadanga Near Egg Godowns to verify the veracity of information. On the way I called two local person namely (1) Sujit Roy (31) S/O Late Satish Roy of Ashighar Coloney PO Ghogomali PS Bhaktinager Dist. Jalpaiguri and (2) Ajay Sarkar (32) S/O Swapan Sarkar of Badur Bagan PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Purba Hatiadanga Near Egg Godowns area as indicated by my source I held raid at the house of Smt Ujjala Saha at Purba Hatiadanga Near Egg Godowns. But seeing us the above noted female accused person tried to flee away from the spot, but we managed to apprehend her. I searched in the house of above noted female accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alamath of the case, as the above noted female accused person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted female accused person with the help of Lady constable for violating the provision of B.E Act. The Search and seizure and arrest were made in between 14.25 hrs and 14.45 hrs on 11.06.2023.

Under the above circumstances, I pray to you that a specific case may kindly be started against the female accused person (1) Smt Ujjala Saha (56), W/O-Late Bimal Saha of Purba Hatiadanga Near Egg Godowns PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
