I, **SMT. DEEPABALI DEY**, Wife of Sri Aroop Sarkar and Daughter of Sri Ajay Dey, presently residing at Mallaguri, Post office & Police Station Pradhan Nagar, District Darjeeling, would like to bring to your kind notice and state as follows.

1. That during the end of the year of 2016 I came into contact with Sri Aroop Sarkar, Son of Sri Apurba Sarkar, Resident of House No. 293, Street No. 7, Adarsh Nagar, Sector 2, B Nasrali, Fatehgarh Sahib, Mandi, Gobind Nagar, Punjab, Pin - 147301 through one common friend and the said Aroop Sarkar disclosed to me that he is residing at Punjab. He also stated that he works in a private firm and earns about Rs. 40,000/- (Rupees Forty Thousand) only per month. Thereafter we used to regularly chat on social media and kept contact with each other. In course of such regular contact we fell in love with each other and decided to marry each other. At that time I used study in B.A. 1<sup>st</sup> Year.
2. That thereafter the said Aroop Sarkar proposed to marry me and I avoided him at that time stating that I want to pursue my studies. On hearing such statement the said Aroop Sarkar stated that he has sufficient income and that he shall allow me to continue my studies and shall also allow me to do job as per my choice. Due to such proposal and mental pressure I was compelled to submit to the demand of the said Aroop Sarkar and in spite of reluctance of my parents I compelled my parents to agree to my marriage with the said Aroop Sarkar.
3. That my marriage with Aroop Sarkar, Son of Sri Apurba Sarkar, was solemnized on 26.02.2018, before the District Sub-Registrar, Jalpaiguri and Ex-Officio Marriage Officer and subsequently a Social Reception was also Organized on 01.03.2018 at Rabindra Nagar, Near Subhashpally Bazar, Siliguri, District Darjeeling and after the solemnization of my marriage my husband took me to his house as mentioned above and since then I have been residing at my matrimonial house.

4. That after few months of my marriage my husband and my in-laws, namely my father-in-law Sri Apurva Sarkar, my mother-in-law Smt. Krishna Sarkar and his married sister-in-law Smt. Pinki Sarkar, Wife of started torturing me both physically and mentally. They stopped me from keeping any contact with my friends and relatives and my mother-in-law also took all my jewellery and other valuable belongings from me. However he used to pass his time with his girlfriends and chat with them over his mobile phone in my presence and on being protested he used to physically assault me.
5. That my in-laws also did not allow me to continue my studies and also torn all my books and other study materials and also stated that they shall not allow me to sit in the examination. It is worth mentioning that they used to force me to work as a house maid and in the event of any neighbour visiting their house that used to say that I am mentally unstable and unable to communicate properly. I was not even provided with adequate food and cloths and was passing my days in a miserable condition.
6. That thereafter I conceived and thereafter I stated that I want to go to my father's house for delivery, however initially they refused to my proposal. Thereafter as the date of delivery came closed and I as unable to continue doing the house hold chores as usual and also considering the fact there would be a huge medical expense at the time of delivery, my husband Sri Aroop Sarkar and his family members agreed to send me to my paternal house.
7. That thereafter my husband took me to his sister's house at Coochbehar and we stayed there for few days. Even while staying at his sister's house, my husband Sri Aroop Sarkar and his sister Smt. Pinki Sarkar abused me on petty affairs and also being unable to do household work as I was pregnant. They also assaulted me physically for being unable to do the household works as I used to do earlier and I had to bear such torture while I was pregnant and going through severe illness and agony.
8. That thereafter I came to my paternal house in the month of May, 2019 and I gave birth to a male child on 06.08.2019 at Mukherjee Hospital, Siliguri and the necessary expenses in this regard was borne by my father and my husband and/or my in-laws did not visit Siliguri even after the birth of my child and till today they have not visited Siliguri even once and they are only putting pressure po me over mobile phone to return to my matrimonial house at Punjab.
9. That during my stay at my matrimonial home at Punjab I was regularly tortured mentally and physically by my husband and my in-laws. I use to bear such torture only with the hope that good sense would prevail upon my husband and my in-laws and they shall change with the passage of time.

10. That in the month of May, 2019 I somehow convinced my in-laws to allow me come to my matrimonial home and ultimately I was compelled to come out of my matrimonial.

11. That having no other alternative I returned to my paternal house and I gave birth to my son and since then I have been residing at my father's house. My husband and other in-laws did not even allow me to take few necessary articles required including my cloths etc.

12. That owing such assault and physical torture I sustained severe injury on my head, back, hand and other parts of my body including my private parts. I thereafter had to be medically treated by the doctor on number of occasions and all the medical documents and papers are in the custody of my husband.

I therefore kindly pray before your goodself to kindly consider my prayer with sympathy and take immediate steps against my husband and my other in-laws namely Sri Aroop Sarkar, my husband Sri Apurva Sarkar, my father-in-law Smt. Krishna Sarkar my mother-in-law and Miss \_\_\_\_\_ sister-in-law, all Residents of House No. 293, Street No. 7, Adarsh Nagar, Sector 2, B Nasrali, Fatchgarh Sahib, Mandi, Gobind Nagar, Punjab, Pin - 147301 and book them for the offences committed by them.
