**Re: Written Complaint to be treated as FIR
against Sri. Hanuman Singh @ Munilal Singh,
Sri. Ajoli Singh and Sri. Rajesh Singh for Theft,
Vandalism of movable and immovable property,
Criminal Trespass, Voluntarily causing hurt and
thereafter forcibly occupying my land.**

Sir,

I am Lochiman Bibi @ Lachiman Bibi @ Lakhi Bibi @ Lachiman
Nesa, wife of Md. Halaluddin, resident of Matigara Railgate no.1,
Biswas Colony, District- Darjeeling, PIN- 734101.

Sir, I along with my husband were residing in above mentioned
premises for 40 years and we are the occupiers of the said landed
property.

Sir, I along with my husband belongs to minority community, we
are old and frail and we have no one to rely upon except ourselves.

Sir, the abovenamed accused persons were regularly threatening
us to leave and vacant the above mentioned premises or else we
shall face dire consequences.

Sir, facing such threatening, on 31.03.2012 I along with my
husband went to Matigara Police Station to lodge written
complaint against the said accused persons named above, but till
date no steps were taken by your office in this regard.

Sir, soon after lodging the said written complaint the accused persons started to threaten us with dire consequences and started verbally and physically abusing us as well, we are only two lonely aged people against Munilal's gang of goons, we are no match for them, since our lives were in danger, we out of fear, went to our relative's house for three days, and when we returned we were shocked by the state of our house, everything was turned upside down. Hanuman Singh @ Munilal Singh along with Ajoli Singh and Rajesh Singh illegally and forcibly broke into our house and had stolen two cows, three goats and an amount of Rs. 15,000/- (Fifteen Thousand) and some other valuable articles were also missing from our house.

Sir, again on 22/05/2012, we lodged a written complaint against the abovementioned accused person before your office.

Sir, on 23/05/2012, the abovenamed accused person forcibly entered our house, physically assaulted us with fists and blows, vandalized and broke my entire house and threatened us to withdraw all the complaints against them or else they will burn me and my husband alive.

Sir, again on 25/05/2012, we the hapless and helpless old person went to Additional Superintendent of Police, Siliguri and lodged a written complaint against these accused persons for forcibly trespassing and occupying our property and also threatening to kill us by burning alive.

Sir, since then we are homeless and running from corner to corner for demand of justice.

Sir, on 12/02/2013 we again requested the then O/C, Matigara P.S. to take action against the said accused persons as we were continuously being threatened for life but instead of taking any action, we were kicked away from the Police station.

Sir, on several occasions we went to Matigara P.S. but we were always thrown out from the Police Station and there were no one to hear our grievances.

Thereafter, on 11/01/2014, we went before Deputy Commissioner of Police, Siliguri and lodged our grievances before him and demanded justice but all went in vain.

On 09/04/2014, we went before O/C, Matigara P.S. again our grievances were unheard.

Sir, all these years, we were continuously being threatened to withdraw all complaints against these accused persons, also we went from corner to corner for demand of justice but we were unheard and unattended by the authorities. Thereafter, my husband fall sick he was diagnosed with TB and most of our time went behind his treatment and running from places to places.

Sir, it is necessary to state here that these accused persons are land Mafias and they are running their business with the aid of some political persons and police persons.

On 14/03/2021, we went before I/C, Matigara Out Post, Siliguri and narrated the entire incident of criminal intimidation, Threat to life, Breaking and Vandalism of our entire house, theft, abuse and physical assaults, trespassing and forcibly occupying our entire property. *That day I was beaten by the Police official of Matigara P.S. and only after the Intervention of P.C.P, Siliguri, I was ~~rescued~~ rescued.*

On 15/03/2021, we went before Commissioner, Siliguri Metropolitan Police, Siliguri with same prayer demanding justice.

Sir, all these years we are living tremendous threat and fear and homeless, running from here to there, hiding from the said accused persons.

Sir, as narrated above, I request your good self to kindly treat this complaint as FIR and arrest the said accused persons and also

help us to resettle at our said property which is now under their illegal and forceful possession and also provide us protection from the said accused persons and their team of goons.

Sir, I being a poor old lady, therefore request your good self to initiate proper steps regarding the said matter at the earliest so that conscionable justice can be done.
