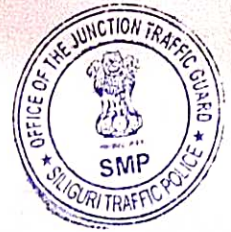


In producing herewith 02(Two) arrested persons namely [1] Pintu Das, S/O- Lt. Haripada Das of Srivash Colony, Fulbari-I, Ps- NJP, Dist- Jalpaiguri (Paddler of Toto (E-rickshaw), having number plate No.WB73G-0246, Silver Colour). [2] Ajay Majumdar, S/O- Sripada Majumdar of Prakash Nagar, Dadabhai Colony, W/No.43, Ps- Bhaktinagar, Dist- Jalpaiguri (Paddler of Toto (E-rickshaw), without number plate, Red Colour), along with their Toto under seizer, I SI. Arindam Chatterjee of Junction Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against them to the effect that, on 12.06.2023 I along with C-180 Biswajit Roy and CV-254 Karun Singha while performing traffic regulation duty at NH-10, near Darjeeling More, Ps- Pradhan Nagar, Dist- Darjeeling found that, the above noted persons was plying their Toto (E-rickshaw), as noted above on NH-10 by violating Govt. Order vide **Notification number 1526/1(1)/-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal** and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.

Accordingly, I along with force apprehended them and on asking they could not produce any valid documents nor could able to express any satisfactory reason to do like so. Further asking they stated their name and address as noted above.

Finding no any alternative way I arrested them u/s 41 Cr. P.C and seized their Toto form their possession u/s 102 Cr. P.C by preparing proper arrest memo and seizure list and brought them to Pradhan Nagar Police Station for custody.

I, therefore pray before your kindness that, kindly lodge a specific case in proper section of law against them for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
