I, SI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that on 11.06.2023 at 2215 hrs I received a secret source information that one person namely Rajdip Kole @ Dewari (44) s/o Lt. Shibu Kole of Bhaktinagar, NJP Main Road, Ward NO.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at abandoned quarter at Ambikanagar, under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 671 date: 11.06.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for abandoned quarter, ambikanagar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 2235 hrs we arrived at the shop of Rajdip Kole @ Dewari (44) s/o Lt. Shibu Kole of Bhaktinagar, NJP Main Road, Ward NO.-35, PS-New Jalpaiguri, Dist.- Jalpaiguri and being identified by the source I held raid at the ambandoned quarter at Ambikanagar where the above noted accused person selling ID Liquior. Accordingly as per the indication of Source I managed to apprehended him. During raid the persons who were taking liquor was able to fled away from the spot. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2255 hrs to 2325 hrs on 11.06.2023.
