**Subject: First Information Report against the owner of Krishna Enterprise and students of Inspiria Knowledge Campus.**

Respected Sir,

I, Abhishek Singh, Son of Jitendra Kumar, by profession practicing advocate at Calcutta High Court, Circuit Bench at Jalpaiguri, presently residing at Tumbajote, Matigara, Siliguri, Darjeeling, West Bengal, would like to bring to your kind information the details of the incident that took place against me at around 5 PM on 10.06.2023 near Passport Office Himachal Vihar. Sir I went to a shop named Krishna Enterprise to purchase some commodities. The shopkeeper Sri Panchanan Gupta, started behaving in a very rude manner as soon as I asked him to give me a lassi by stating that there are other customers and I have to wait to get the goods. I politely waited and it was almost after 7 minutes he gave me lassi and then and there started shouting upon me to pay. To this I stated to him that I also need other products and that he should not be so rude to his customers. He sold me the goods and I paid him through Gpay online transaction. Thereafter, when I was leaving his shop premises, the shopkeeper wrongfully restricted me and asked me to meet him later. I objected to it by saying that I am a lawyer and if he has anything to say to me he should get my appointment. To this he suddenly insulted me for being a lawyer and started making fun out of me. When seeing his slander directed towards me and defamatory attitude, I was walking back towards my bike. Suddenly the shop keeper started instigating some students of Inspiria Knowledge Campus and one of the students threatened me that their group of students studying at Inspiria Knowledge Campus will beat me if I send any letter of complaint against the shopkeeper and that they were evidence in favour of the shopkeeper. When I asked the student to not get involved in this issue as they

were unaware of the transaction, they started giving me rude replies and suddenly the shopkeeper along with two unknown students abetted others who were present and then one Adarsh Tamang and another Dinesh Kumar Singh who were also unaware about the transaction started threatening me. Adarsh Tamang abused me by calling me "Chikne tolai parkaunchu" and upon listening to these words, I told him to be in his limits. However, he chose to take law into his own hands and started beating me with fists wearing knuckles, blows and kicks. They in the same transaction injured my nose which was profusely bleeding, back of my head which was swollen and busted open my lips. In this incident, they broke my HP Laptop, Burberry eye glass, and my Royal Enfield bike indicator.

Sir the entire incident arose due to the hot altercation between the shopkeeper and me. Thereafter, the shopkeeper took the liberty to abet the four students out of which two students namely Adarsh Tamang and Dinesh Kumar Singh attacked me very dangerously and the other two students were restraining me. Sir I do not know these other two students but I saw them leaving the place of incidence on bike which came to pick them up bearing no. WB 74 AU 3175. All of these aforesaid five anti social elements have caused huge pain and trouble to me. Now therefore in these set of circumstances, I request you to trace these aforesaid 5 culprits being Owner of the Shop Krishna Enterprise, Adarsh Tamang, Dinesh Kumar Singh and other two students of Inspiria Knowledge Campus who ran away with the assistance of a biker on bike bearing no. WB 74 AU 3175.

Sir this is not a regular case, it must be treated in special manner. The shopkeeper knowing that I was a lawyer arranged his hooligan customers/students who are involved in all sorts of nefarious activities near his shop. They usually smoke cigarettes, and consume drugs. One of the student Dinesh Kumar Singh was clearly under the influence of drugs. All these students come to Krishna Enterprise only to procure unwanted items.

Sir, advocates play a very vital role in ensuring safety in the society and making a safer world by providing every individual an easy access to justice. Advocates are the ones who help persons to know their rights and duties against the members of the society. All such incidents against advocate instills fear in the mind of the advocate who will lack zeal to perform his duty. In this instant case, knowing fully well that I am an Advocate, these notorious elements arranged attack against me. Therefore, in light of the above shared information, I request you to kindly arrest these miscreants, make a very strong case against them and produce them before appropriate forum and proceed against them without sympathy of age or class of these group of individuals.

I shall be truly indebted if you could initiate action to get them punished for their activity of outrage against my life, the damage caused to my property and the shame that I was subjected through due to their rude words.
