you that One Rajendra Rai S/O dhanraj Rai resident of Khopalasi, po-
new chamta, ps-matigara, Dis-Darjeeling, who falsely by
misrepresentation introduced himself as true and genuine owner of
the Land measuring 16.5 Decimal situated at /, recorded in khatian
no-1329 (L.R), in plot no-235(R.S), 373(L.R) & 237(L.R) 372 (L.R) (5.5
Decimal in L.R Plot no-373 & 11 Decimal in L.R plot no 372, J.L no-
21, Mouza -Khopalasi, pargana-Patharghata, under patharghata
Graqm panchayet, PS-Matigara Dis-Darjeeling and the said is butted
and bounded by north -Jhaiguri Mouza, By south- 12-0 wide Kacha
Road & west -land of Rupa tamang,

And Offered me to purchase the said Land accordingly He (Rajendra
Rai) entered into an agreement and he ready to sale the
abovementioned land of Rs. 90000/per katha, to me, for that he
received of Rs.180000/ on 21/03/2022 as advanced money.

It is pertaining to note that he further received of Rs.300000/ on
25th July 2022 through cheque being no-159267. He also received of
Rs.160000/ on the same date through cheque being no-479053.

When I request him to execute sale deed in favor of me, but he
intentionally avoiding me, and his conduct was very suspicious.,.

Having suspicion over him I searched about the above mention land
, and I found that said Rajendra Rai is not the actual and true owner

of the land , and actual owner of the Land is Broj kishor Prasad
,(enclosed here with Xerox copy of Khatian of Broj kishor Prasad) in
spite of that he received of Rs. 640000/(six Lakh forty thousand)
(enclosed here with Xerox copy of money receipt) in total, by
practicing fraud and inducement and misrepresentation, for which I
lost huge amount rupees and now I am in mental trauma.

When ever I asked him to return my said money he threaten me with
dire consequences and clearly refused me to return my said money .

Sir ,I am now sixty years old ,and it was whole life income and saving

With great hope and expectation I appeared before you, so that
justice may kindly be imparted to me.

So it is my humble request to take necessary action against
Rajendra Rai.
