Respected Sir, I Jit Maya Ramdam w/o Ex H/capt
Dharam Bahadur Ramdam aged 65yr residing at
Salnikpuri, Khopalashi (Khaprail) P.O - New Chunta
Dist- Darjeeling (W/B). Today I am going to file a
complain against my daughter-in-law (Pinky Ramdam)
presently residing at C/o Bir Bahadur Gurusung, Durga
mandir, Rabindra Sarani, Kadamtalla, Dist- Darjeeling
Contact No- 8293751984.

I am a patient of heart, anxiety,
kidney, sleep disorder and many others. When I
along with my families was in a way to Haridwar,
I was shocked to listen my son was missing for
the reason my daughter-in-law lodged false FIR
against me, my elder daughter and son. My son
got married with her on 23 Jan 2007 and separated
from us on 2007, just after 8 month of marriage
with mutual understanding (copy available with us).
There was no communication maintained with them,
even relation. She used to tortured me and my families
as per ^{the} direction given by her families. One worse
incident happened with me, she came to hit me
by stick but I was lucky to save by my son.
She used to use abuses language too. This was
the reason my son took her in quarter, after
separation from house, since then there was no
relation maintained. She used to call me from different
numbers and threaten me, I have already given one case
again I will give another case against you all and put
in jail. She is greedy, only require money from my
son.

The main reason why she filled
complaint - is her affair with William Vishnu
which my son caught on her mobile; evidence are
available ~~with~~ with my son. The people who
were responsible for all her bad doing are
her mother Lata Sunar, Sister Roma Shaktshankar
Brother Tek Bahadur Sunar, Friend Sujata Nandi
Gassainpur, Bagdogra, BF William Vishnu. They
all provoke her to put all of us in jail and to
run with William Vishnu because all the properties
are in her name. Her BF urge her, that he will
come on 16 Aug 2022 and fortunately
she run on that particular date, spend two days at
outside and came to her sister house. These are the
reason I got heart attack and went to Hospital
twice now discharged but still worrying
happen next, although she wanted to put all my
families in jail in any cost. I cannot take proper
rest for overthinking about this trauma. I don't
want to die. If anything happen to me is the future
my daughter-in-law and all her connectivity person
will be responsible for it.

It is very painful to mention over
here. Pinky with her families members, friends once came
in my house when only my daughter and two minor
grandson ~~these~~ were available in house. They
entered inside my house through everything on ash.
They do not stop when my daughter tried to stop
them saying my parents are not available. They
all harassed them badly. My 50000 left from my
house but didn't complain because it's all about
family matter but when Pinky crossed the limit and
thing came against my self respect and health issues,
know I am flashing all these. They also used
abused languages. Her sister crossed the limit
even hit to my grandson on the roof of my house.

At last being a patient and also a senior citizen who is lying on bed pray you to please take legal action all of them as soon as possible. My life is in your hand. I cannot bear these days today harassment anymore. Statement written as per one by my son (Jeetu Randal). I am sending FIR complain in original with my son due to unable to stand and walk.
